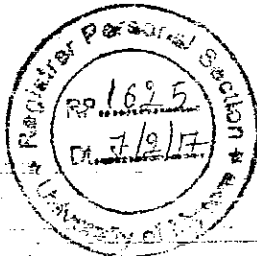

Draft Statutes relating to establishment of Sri.P.R.Thippeswamy Chair in the University, framed under Section 40(1) of Karnataka State Universities Act-2000.

1. Title and commencement:


- a. These Statutes shall be named 'Sri.P.R.Thippeswamy Chair in the University of Mysore statutes 2016.
- b. These Statutes shall come into effect from the date of assent of His Excellency, the Chancellor of the University.


2. Placement:

Sri.P.R.Thippeswamy Chair is to be established in the Folklore Department of Kuvempu Institute of Kannada Studies.

3. Purpose:

- 1. The Folklore Professors are invited to study Sri.P.R.Thippeswamy contribution to the fields of painting and literature and the study is to be brought out in a book form.
- 2. Sri.P.R.Thippeswamy paintings, writings and manuscripts are to be collected and documented.
- 3. A detailed descriptive catalogue of exhibits displayed in Folklore Museum of the University is to be brought out as the said Museum is a result of the relentless and dedicated effort of Sri.P.R.Thippeswamy. In addition, the index of the exhibits is to be prepared.
- 4. The articles and writings of Sri.P.R.Thippeswamy are to be collected and volumes containing the articles by different authors on Sri.P.R.Thippeswamy are to be brought out.
- 5. A documentary film should be produced on the multi faceted Sri.P.R.Thippeswamy and the same is to be screened widely,
- 6. On the Birth Anniversary Day of Sri.P.R.Thippeswamy Seminar, symposia and discussions are arranged pertaining to his life and achievements.

7. Felicitation is to be arranged for those who have made significant contribution to the field of painting and folklore.

8. Training camps are to be arranged for the folklore students of Kuvempu Institute of Kannada Studies and the artistes in general and also demonstration classes are held on folk arts. For this, the folklore experts are appointed on a part-time basis with honorarium.

5. Financial Involvement:



Professor:

A three member panel consisting of Professors who are experts in Kannada literature and having a special inwardness in painting and sculpture is formed after a thorough discussion in the Departmental Council. One Professor selected shall be appointed for a period of one year in accordance with the decision of the Syndicate. The right of continuation at the end of this tenure or termination vests with the Syndicate.


If the Visiting Professor's services are satisfactory and if the services are necessary, the Authority can take a decision to continue the services of the said Professor, for a further period of six months or one more year.


b. Typist-Cum-Clerk (T.C.C)


Keeping the educational qualification in view appointment for the post can be made to Sri.P.R.ThippeswamyChair for a period of one year on a temporary basis on a consolidated salary. This appointment can be continued according to the recommendations of the Visiting Professor and the Head of the Department.

C. Group D Employee:

Appointment is made to Sri.P.R.ThippeswamyChair for a period of one year on a temporary basis on a consolidated salary. The appointment may be continued according to the recommendations of the Visiting Professor and the Head of the Department.
