## ICPS- RESEARCH ASSOCIATE PROGRAMME (ICPS-RAP)

#### **GUIDELINES**

Applications are invited for ICPS Research Associate Programme (ICPS - RAP) from Indian citizens initially for a period of two years. Applicants below 32 years of age as on the last date of making application and possessing minimum of post-graduation in disciplines such as Social Science, Law, Journalism, Management, Environmental Studies, etc. from recognized Institutes in India or abroad are eligible for the Programme.

#### Work Profile

Research Associates shall be required to undertake the following work:

- Assisting in devising new academic programmes including developing their course contents and planning their effective execution
- Assisting in planning of and conduct research projects and studies
- Organising research activities (seminars/ conferences/ workshops, etc.) including preparing their reports and summaries
- Data collection and data analysis
- Implementation of training programmes
- Editing articles for publication in journals
- Develop research papers/ technical notes
- Assist in discharge of administrative work relating to the above activities
- Additional responsibilities and duties as may be assigned

#### **Process of Selection**

The process of selection will involve following steps:

Writing to the top NIRF ranked Universities and Institutions

Top NIRF ranked universities and institutions will be sent mails requesting them to inform their students/ former students to avail of the ICPS Research Associate Programme by mailing at <a href="mailto:icps.rap@sansad.nic.in">icps.rap@sansad.nic.in</a> their following details to the ICPS: (i) Full Name, (ii) Mobile Number, (iii) E-mail, (iv) Aadhar Number.

Procurement of Names/ Basic Details

Interested candidates will be required to furnish their above details using only their official/ institutional emails (name, roll number, etc., based) provided/ generated by their respective institutes having domain name of the Institute, e.g., xyz@iitd.ac.in.

The applicants are NOT TO SEND ANY PHYSICAL APPLICATIONS to ICPS nor through the emails other than their official/ institutional emails as the same will not be entertained.

Short-listing of Names

ICPS will shortlist the candidates and forward the link to the portal for receiving online applications to the shortlisted candidates at their registered emails.

After registering on the portal, the shortlisted candidates will be able to fill-in the application form online and upload the required documents on the portal by the stipulated date and time.

Scrutiny of Applications

All those applications received by the stipulated date and time and will be complete in all respects, will be scrutinized by ICPS.

• On-line Interview

An Online Interview of the scrutinised candidates will be conducted and the successful candidates will be informed by their registered emails.

#### **Logistics & Support**

Research Associate shall be provided working space, desktop computer, internet facility, access to ICPS and Parliament Library for consultation of books/ reports/ debates and other publications available therein and also provided photocopy facility free of cost only in respect of documents specifically relating to the areas of study.

#### **Terms and Conditions**

The candidates selected for ICPS-RAP shall be required to sign the 'Terms and Conditions' document and abide by the same. The terms and conditions will *inter alia* include the following:

- (i) Research Associate shall not work in any organisation during the period of the Programme.
- (ii) In case the Research Associate is applying for any job during the period of the Programme, she/he shall take prior permission from ICPS.
- (iii) The Research Associate will observe office discipline, punctuality and follow regular office timing during the period of Programme.
- (iv) The place of posting will be Delhi.
- (v) Leave of 12 days shall be allowed in a year on pro-rata basis.
- (vi) An Annual Performance Appraisal of the Research Associates would be undertaken through an Annual Performance Report (APR)
- (vii) ICPS will not provide any accommodation/ transport facilities to the Research Associate. She/ he will have to make her/ his own arrangement for accommodation/ transport during the term of the Programme.
- (viii) ICPS shall have all the right to cancel the Programme awarded to any Research Associate, without assigning any reason, during the Programme at any point of time.
- (ix) The decision of the Senior Vice-President of the Institute shall be final in all matters concerning the Programme.
- (x) The Research Associate shall not claim any employment in ICPS/ Lok Sabha Secretariat after completion of the Programme.
