During this meeting, a key resolution was made regarding changes to the subject titles within the MA in Theology programme. It was noted that these changes are related only to the titles. The content, course requirements, and all other aspects pertinent to the courses will remain unchanged.

The BoS unanimously approved the proposal to revise course titles to better reflect the content and focus of each subject. These changes are as follows:

Course Description

This course explores the theological and biblical underpinnings of the family unit, examining its origins, purpose, and evolving dynamics within a Christian context. - Demonstrate the ability to engage with complex family dynamics in pastoral and ministerial settings with sensitivity and theological acumen.

Textbooks

1. "The Family: A Christian Perspective on the Contemporary Home" by Jack O. Balswick and Judith K. Balswick. This book provides a thorough examination of family life from a Christian perspective, addressing vital issues such as marriage dynamics, parenting approaches, and broader family relationships. It integrates theological insights with practical guidance, making it a valuable resource for understanding and navigating the complexities of modern family life in light of Christian values and teachings.

- 2. "God, Marriage, and Family: Rebuilding the Biblical Foundation" by Andreas J. Köstenberger and David W. Jones. This book offers an extensive scriptural exploration of the foundations of marriage and family. Covering topics such as sexuality, divorce, and the roles within the family, it delves into what the Bible says about these critical aspects of life. The authors aim to provide a solid Biblical grounding for understanding and living out family and marital relationships.
- 3. "The Body: A Theological and Exegetical Exploration" by Craig S. Keener, This work presents a detailed theological and exegetical study on the concept of 'the body' in the Bible. While not exclusively focused on family, it provides valuable insights into how the body is viewed in scripture, which is foundational to understanding topics like gender roles, sexuality, and personal identity within the context of both the individual and family life. Keener's analysis contributes to a more holistic understanding of the physical and spiritual aspects of personhood in Christian theology.
