I Sem LL.M: Corporate, Fiancé & Investment Law:

To be added to unit -I; Social harmony & stability of Government (Law & order).

III Sem LL.M: Comparative Constitutional Law-II (Rights & Liberties)-

Right to Counsel, Right to bail, Protection against cruel and unusual Punishment: Death penalty (To be shifted from unit-II to Unit III.)

Freedom of Assembly, Association, Movement, Residence (To be shifted from unit III to unit IV)

IV Sem LL.M : Air & space Law: Space Debris: Role of ISRO & NASA (To be added to IV unit)

Regulation:

In the existing regulation, there is no mentioning of minimum marks to be secured in each theory paper. Therefore, minimum of 25 marks is fixed to be secured out of 70 in each paper for passing. However there is no minimum for Internal Assessment marks of 30.




