

Proceedings of the BOS (PG) Meeting Held on 2019

1. The Hon'ble members of the BOS included, on consensus, few examiners for the BOE of all the Universities in Karnataka State.

2. The members have decided to consider some parts of the syllabus in various modules of all the courses as Self-Study Material. In this direction the concerned teachers (who are teaching the same courses) will be asked to Italicize (Bold it) some portions. A note will be given by saying that the portions of the syllabus, which is Italicized is the Self-Study Material, however, the questions may be included in the examination relating to the same. This is done basically to reduce the burden of the teachers as it is practically not possible to cover the syllabus with the given time (It need not be considered as change in syllabus).

3. The members have unanimously agreed to say that the modified syllabus has to be with effect from 2020-21 Academic year so that the students will also be benefited.

4. The members have decided to visit few PU Colleges to brief the merit of taking the Subject/Course, Economics, during the UG and PG levels, which has to be done to improve the subject Economics.

5. The members have strongly felt that there should have been representation from other departments/universities as per the BOS statutes.
