Pursuant to the approval of the Syndicate at its meeting held on 24-03-2016, **Sri Praveenkumar Mellalli** is appointed as **Assistant Professor in Public Administration purely on temporary basis** in the Department of Studies in Public Administration, Manasagangothri, Mysuru as per provisions under Section 56 of KSU Act, 2000, on a consolidated salary of Rs.50,000/- p.m. without any usual allowances, against the newly created sanctioned vacancy vide Govt. letter cited at ref. (1) above, for a period of two years or until further orders, whichever is earlier.

He is directed to report to duty to the Chairman, Department of Studies in Public Administration, Manasagangothri, Mysuru, within SEVEN (7) days from the date of receipt of this order, failing which the offer of temporary appointment shall be cancelled.

At the time of joining to duty, the appointee is required to produce all the original Certificates relating to his Age, Educational Qualification, etc., to reporting authority for reference and return.

No TA/DA will be paid for the journey performed for joining to duty.


At the time of reporting to duty, he should execute an undertaking as follows:
