I am pleased to inform you that based on the Joint CSIR-UGC Test for Junior Research Fellowship and Eligibility for Assistant Professor conducted on 17th June 2018, you have been identified for award of fellowship under the scheme of **National Fellowship for Scheduled Caste Students for the year 2018-19**.

The tenure of the Fellowship is five years and it commences from the date of declaration of NET result for NFSC i.e. 17.09.2019 (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

The candidate is required to get admission and registration for regular and full time M.Phil/Ph.D. course in a University/Institution recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of scheme and Notification dated 17.09.2019. The same can be accessed at https://www.ugc.ac.in/ugc_notices.aspx.

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on www.ugcnetonline.in. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.

Pursuant to the approval of the Vice-Chancellor **Mr. Ravikant Shekhar. S/o Chhattu Lal Ram, Nirmal Bhawan, Pcc Path, Ashok Prasth Colony, Near Dibadih Over bridge Doranda, Jharkhand- 834002, India**, is awarded the National Fellowship for SC Candidate (CSIR-UGC- NET) for the year **2018-19 in Life Science**. The National Fellowship for SC is tenable for five years subject to the satisfactory progress report of the fellow. He is eligible to draw **Rs. 31,000/-** per month for first two years and **Rs. 35,000/-** per month for next three years. He shall work on the research topic **"DNA BARCODING AND METABOLITE PROFILING OF SELECTED GI-TAGGED NATIVE PLANT VARIETIES OF KARNATAKA"** under the guidance of **Dr. Geetha N., Associate Professor, DOS in Biotechnology, Manasagangotri, Mysuru** He is entitled to an Annual Contingency Grant of **Rs. 12,000/-** per annum for initial two years and **Rs. 25,000/-** per annum for remaining three years as per rules in force. He shall utilize the grant with the prior permission from the **Chairman, DOS in Biotechnology, Manasagangotri, Mysuru** and also on the recommendation of the guide on each occasion and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

He should report herself for duty to the **DOS in Biotechnology, Manasagangotri, Mysuru** within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. **The fellowship will be effect from 17.09.2019 or the date of joining whichever is later.**

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier,

He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the original certificates of qualifications, age and date of birth before **DOS in Biotechnology, Manasagangotri, Mysuru** for verification and return, and award of the National Fellowship for SC is subject to the conditions stipulated in the Comprehensive Ordinance and UGC guidelines issued from time to time for award of the Fellowship.

Regarding Payment of fellowship amount the awardee is required to follow the instructions given in the award letter.

3. The candidate should submit progress reports certified by the Guide and Director/Chairperson of the Institute/ Department with the fee paid challan in every year. If the candidate fails to submit two Consecutive Progress Reports in time, it amounts to cancellation of the Registration, and this shall be notified by the Registrar(Evaluation). For any reason the fee paid, will not be reimbursed to the researcher.
4. While submitting the progress report Tuition fee, Processing fee and Laboratory fee has to be paid to the Examination Account and the Challan should be enclosed.
5. Examination fee has to be paid to the Examination Account of the University and the Challan has to be furnished at the time of submission of Final Synopsis and Thesis.
6. The Research candidate shall strictly adhere to the Regulation mentioned above.
7. On completion of research work, 10 copies of synopsis and 4 copies of thesis, an electronic version of the thesis, evidence of two research publications, prescribed application form for submission of thesis and synopsis, challan for having paid the examination fee, declaration signed by the candidate and certified by the guide for having prepared the thesis, No Due Certificates from the Department, Library and the Hostel should be submitted through the guide and the Director/Chairperson of the Institution/Department. 8. If candidate fails to submit the thesis even after 7 years i.e after getting one year of extension period, the Ph.D registration in the respective subject stands automatically cancelled.
