- The Supervisor/Guide/Fellowship awarding Authority/Lectureship appointing Authority Viz. University/Instt. must verify the original record/certificates including the CGPA Conversion/Percentage and recognition of the University/Instt. of the candidate regarding eligibility criterion & caste/PWD certificate (if applicable) for this test while considering him/her for fellowship/appointment, as CSIR-HRDG (Examination Unit) is not responsible for the same.
2. Extract of Eligibility Criterion as laid down in the Notification No.10-2(5)/2018(ii)-E.U.II published in Employment News dated 22nd - 28th September, 2018 for this examination:
- (a) **EDUCATION QUALIFICATION** : M.Sc or equivalent degree/ Integrated BS-MS/BS-4 years /B.E./B.Tech/B.Pharma/MBBS with at least 55% marks for General and OBC candidates and 50% for SC/ST and PwD candidates.
- Candidates enrolled for M.Sc or having completed 10+2+3 years of the above qualifying examination as on the closing date of online submission of application form (i.e. 17.10.2018), are also eligible to apply in the above subject under the Result Awaited(RA) category on the condition that they complete the qualifying degree with requisite percentage of marks within the validity period of two years to avail the fellowship.

The eligibility for Lectureship of NET qualified candidates will be subject to fulfilling the criteria laid down by UGC. Ph.D degree holders who have passed Master's degree prior to 19th September 1991, with at least 50% marks are eligible for lectureship only.

(b) **UPPER AGE LIMIT & RELAXATION:**

- (i) JRF: Maximum 28 years as on 01.07.2018 {relaxation in upper age up to 5 years for candidates belonging to SC/ST/PWD/Female candidates and up to 3 year for candidates belonging to OBC (Non Creamy Layer) (Central list only as provided in National Commission for Backward Classes website www.ncbc.nic.in)}.
- (ii) LECTURESHIP : No upper age limit for Eligibility for Lectureship.



1. The Doctoral Candidates should conduct research for a minimum period of 03 years and maximum period of 6 years from the date of provisional registration as per the 8.1(a) Ph.D Regulation 2017.
2. The Ph.D registration is valid for a period of 6 years from the date of provisional registration and it is extendable by one more year on request by the candidate well in advance with a recommendation of the Guide and Director/Chairperson of the Institute/Department followed by approval of Vice-Chancellor on payment of the prescribed fee.
3. The candidate should submit progress reports certified by the Guide and Director/Chairperson of the Institute/Department with the fee paid challan in every year. If the candidate fails to submit two Consecutive Progress Reports in time, it amounts to cancellation of the Registration, and this shall be notified by the Registrar(Evaluation). For any reason the fee paid, will not be reimbursed to the researcher.
4. While submitting the progress report **Tuition fee, Processing fee and Laboratory fee** has to be paid to the Examination Account and the Challan should be enclosed.
5. Examination fee has to be paid to the Examination Account of the University and the Challan has to be furnished at the time of submission of Final Synopsis and Thesis.
6. The Research candidate shall strictly adhere to the Regulation mentioned above.
