


KARNATAKA DST-Ph.D. FELLOWSHIP IN SCIENCE AND ENGINEERING

I accept the award and undertake that:



- (ix) I further understand clearly that I shall have no claim whatsoever for regular/permanent absorption on expiry of Fellowship.


