Pursuant to the approval of the Hon'ble Vice-Chancellor, Ms. AKSHATHA S, D/o. SHANKAREGOWDA, ANKANNANADODDI, KERAGODU POST, MANDYA-571446 is awarded the UGC-JRF in **History** on a Fellowship value of **Rs. 31,000/-** per month initially for a period of two years. She shall work on the research topic "NADUS AND AGRAHARAS DURING HOYSALA PERIOD IN MANDYA DISTRICT" under the guidance of Prof. Saraswathi N, (Rtd) Proffesor, Department of Studies in History, Manasagangothri, University of Mysore, Mysuru.

She is entitled to get An Annual Contingency Grant of Rs. 10,000/- as per rules in force. She shall utilize this grant with the prior permission from the Chairman, Department of Studies in History, Manasagangothri, University of Mysore, Mysuru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, she is entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount. She should report herself for duty to the Chairman, Department of Studies in History, Manasagangothri, University of Mysore, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled.

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, her tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF)

In case, the work for the first two years is not found satisfactory, an additional year will be given to her for improvement. However, during this period she will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, and three will be no further provision for extension. Linator

The fellowship will be effective from 14.08.2019 or date of Joining of Ph.D research whichever is later. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, Department of Studies in History. Manasagangothri, University of Mysore, Mysuru.
