Pursuant to the approval of the Hon'ble Vice-Chancellor, Mr.Yashawanthapal, S/o Annajaiiah, Dindagadu Village, Doddakamaravalli Post, Haranahalli Hobli, Periyapatna Taluk, Mysore District is awarded the UGC-JRF in **Prakrit** on a Fellowship value of **Rs.31,000/-** per month initially for a period of two years. He shall work on the research topic “ ಮೈಸೂರು ಜಿಲ್ಲೆಯ ಜೈನ ಬಸದಿಗಳ- ಒಂದು ಸಾಂಸ್ಕೃತಿಕ ಅಧ್ಯಯನ under the guidance of Dr.P.Padmavathi, Associate Professor, Department of Studies in Jainology and Prakrit, Manasagangothri, University of Mysore, Mysuru.

He is entitled to get an Annual Contingency Grant of Rs.10,000/- as per rules in force. He shall utilize this grant with the prior permission from the Chairman, Department of Studies in Jainology and Prakrit, Manasagangothri, University of Mysore, Mysuru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, he is entitled to draw House Rent Allowance at the rate of **16%** of the fellowship amount. He should report himself for duty to the Chairman, Department of Studies in Jainology and Prakrit, Manasagangothri, University of Mysore, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled.

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, his tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF).

In case, the work for the first two years is not found satisfactory, an additional year will be given to him for improvement. However, during this period he will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, and there will be no further provision for extension.



