Pursuant to the approval of the Hon'ble Vice-Chancellor, Mr.Ananda.P, S/o Puttaraj.H, #4/101, 4th Cross, Janatha Bhadavane, J.P.Nagara, 'D' Block, Mysuru, is awarded the UGC JRF in **Social Work** on a Fellowship value of Rs.25,000/- per month initially for a period of two years. The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, his tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF.)

In case, the work for the first two years is not found satisfactory, an additional year will be given to him for improvement. However, during this period he will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, and there will be no further provision for extension.

The fellowship will be effective from 28-10-2017 or date of Joining of Ph.D research whichever is later. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, Department of Studies in Social Work, Manasagangothri, University of Mysore, Mysuru.

Award of this UGC Junior Research Fellowship is subject to the conditions stipulated in the Comprehensive Ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship.
