Subject: ICHR Study-Cum-Travel Grant Sanction Order in favour of Dr. D.C. Nanjunda Independent, Centre for Study of Social Exclusion and Inclusive Policy, University of Mysore, Mysore -570005, Karnataka.

- 1. I am directed to convey the sanction of ICHR a sum of to Rs.45, 000/- (Rupees Forty Five Thousand only) the above scholar to work on proposal 'Situating Social Justice in the Indian Political Process: Karnataka 1880-1947'.
- 2. I am further directed to release the first installment of the above grant amount to Rs.40,500/- Rupees Forty Thousand Five Hundred only).
- 3. The grant will be released in installments determined by the Council.
- 4. In expenditure out of the grant sanctioned the following limit shall be observed:
- (a) Actual cost of rail/bus fare shall be limited to first class/IIAC fare to the place of research and back to the place of ordinary residence of the scholar.
- (b) Daily allowance for a maximum of 90 days shall be at the rates allowed by the institution of affiliation, if the recipient is employed there, or Rupees Three hundred only (Rs.300/-) a day, if not employed.
- (c) For local conveyance Rupees One Thousand only (Rs.1000) may be allowed per month upto a maximum of three months.
- (d) The total cost of books purchased out of Contingency (Study-cum-travel) grant made under the provisions of Chapter IV shall not exceed of 20% of the Sanctioned grant.
- (e) Any books purchases out of contingency grants in excess of the ceilings specified above shall be deposited either with the ICHR or with the institution of affiliation, upon the end of the period of the Contingency (Study-cum-travel) grant.
- (f) Stationery, Photocopy, Typing and other miscellaneces expenditure subject to maximum of 50% to 60% of the sanction grant.

- 5. To claim any subsequent installment, the awarder shall have to submit to ICHR a report of the work done and statement of expenditure of the previous installment throu, institution of affiliation.
- 6. (a) Upon the applicant being informed of the award he shall be requested to convey h. acceptance, upon which 90% of the grant shall be released to him through his institution of affiliation.

(b) The last instalment, i.e., 10% of the sanctioned grant shall be withheld and released on reimbursement basis only after a certificate of satisfactiory utilization of grant and receipt of a certified satisfactory progress report. Provided that an additional amount of Rupees Five hundred (Rs.500/-) shall be paid to the recipient of the grant over and above the sanctioned amount of grant upon receipt of the said thesis, dissertation or monograph, as lump sum payment for any expenses incurred in providing a copy thereof to the ICHR.

- 7. In case an article prepared with the help of the above grant is subsequently published, an acknowledgement of the grant of ICHR should be made prominently on the inner title page of the published work.
- 8. ICHR reserved the right to terminate the grant in case it is observed that the rules are seriously violated.
- 9. The institution of affiliation, through which the grant is route, shall be paid overhead charges after the receipt of the final report and the statement of expenditure of entire grant.
