1. We are happy to inform that a grant – in- aid of Rs. **2,00,000/- (Rupees Two Lakh only)** has been sanctioned under the scheme of Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching (PMMMNM) for the above research project.
2. For the break-up of the budget approved by the Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching (PMMMNM), School of Education (SoE), Central University of South Bihar (CUSB), kindly, refer to the Research Project Funding and Monitoring Guidelines (copy attached).
3. The first instalment (20%) of the approved grant–in–aid of Rs. **40,000/- (Rupees Forty thousand Only)** will be released after receiving the agreement on the stamp paper, date of commencement and grant-in-aid bill towards the first installment, filled in, stamped and signed by the Principal Investigator as well as the affiliating organization in the prescribed format.
4. The first installment of the grant shall comprise of 100% of the Non-Recurring and 5% of the total Recurring grant approved by the PMMMNM, SoE, CUSB for the total duration of the project. The grant will be released to the Principal of the College/Registrar of the University/Head of the Institution. The breakup approved and the details of first installment are enclosed.

On receipt of Progress Report within 3 months of the commencement of the project, statement of expenditure of 1<sup>st</sup> instalment of grant, the 40% of the total recurring grant will be released as second instalment. The duration between 1<sup>st</sup> instalment and second instalment is 3 months. Before 8 months the Principal Investigator has to claim the last instalment. Needless to say, the final instalment should be claimed at least by the end of the 8<sup>th</sup> month and after producing atleast one research paper on the work done. Remaining 40% will be released on or before 1<sup>st</sup> March, 2020 on the receipt of following documents as final reimbursement:

1. Copy of the final report of project along with 3 soft copies.
2. A consolidated item-wise detailed statement of expenditure incurred during the complete project period in the prescribed proforma duly signed and sealed by the Principal/Registrar and the Principal Investigator.
3. A consolidated Audited Utilization Certificate for the amount actually utilized towards the project duly signed by Govt. Internal Auditor/ Chartered Accountant, Principal/Registrar as well as the Principal Investigator in the prescribed proforma.
4. The unutilized grant if any, may be refunded immediately through, demand draft drawn in favour of the Finance Officer, Central University of South Bihar, Gaya (Bihar).

The Principal Investigator/Institution are expected to settle the accounts immediately on completion of the project. In case the balance grant, if any, is not claimed within **period of research, the same will lapse and no representation will be entertained on this behalf.**

5. The Principal Investigator of the research project will be **Dr. Ningamma C. Betsur** who will be responsible for its completion within 11 months from the date of commencement of the project, or upto 1<sup>st</sup> March, 2020, which is earlier.
6. In case of failing doing so, the Principal Investigator may be debarred from availing all further financial assistance from Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching, (PMMMNTT), School of Education (SoE), Central University of South Bihar, Gaya.
7. All grants from PMMMNTT are subject to the general provision of GFR 2017 and the relevant subsections in the GFR.
8. The Principal Investigator will ensure that the expenditure incurred by him/her conforms to the approved budget heads. The grants-in-aid is subject to all the

9. The amount of grant sanctioned herein to be utilized by the end of the project duration. Any amount of the grant remaining unspent shall be refunded to the Finance Officer, Central University of South Bihar immediately after the expiry of the duration of the project.
- a) If a Principal Investigator fails to complete the project, he/she has to refund the entire amount released with penal interest.
- b) No extension in tenure is permissible in any circumstances.
10. The Principal Investigator has to strictly abide by the guidelines issued in this regard and shall be governed under relevant rules and regulations from time to time issued by Govt. of India/UGC/Central University of South Bihar.


