It is informed with pleasure that the Project Proposal submitted by you (as mentioned in the Reference-2 above) is selected and approved for sponsorship by Inter University Centre for Teacher Education, Regional Institute of Education, Mysuru.

It is further intimated that Rs. 1,95,000 (Rupees One Lakh Ninety Five Thousand) Only is hereby sanctioned for the Research Project.

The approval of the project and the sanction of the amount are subject to the following conditions:

1. The Research shall be confined to the approved and sanctioned proposal only.

- 2. The research report complete in all aspects, as set out in the notification, advertised on 04.09.2019 in The Hindu and in website with link should be submitted on or before 29-02-2020. Any request for extension of time will not be entertained.
- 3. The project report on submission should be accompanied by the certificate of originality, in the prescribed format, issued by the Head of the Institution.
- 4. The amount sanctioned as above will be released as below:
  - I. 75% of the amount, on receipt of the acceptance letter from you and the receipt of Agreement Bond, duly signed by you.
  - II. The remaining 25% of the amount on receipt of the Research Project report on or before 29-02-2020
- 5. The sanctioned amount in instalments as above, will be sent to your Institution Only, or behalf of you. The release of the grant would be through electronic Transfer of funds (RTGS). You are requested to provide the following details for Facilitating e-payments.
  - a. Account Holders/Organization name (or) designation
  - b. Name of the Bank
  - c. Bank Account Number
  - d. IFSC Code
  - e. MICR Code

It would be appreciated if you can send us a photocopy of a cancelled cheque, which has all the requisite details. The bank details in the photocopy of the Cancelled cheque should match with the details given previously.

- 6. An undertaking from the Organization/Institute/Principal/Investigator that it has not obtained financial assistance from any other department of the Central/State Governments for this project or a similar project and the Institute is not blacklisted.
- 7. The spending of the amount should be strictly according to the Head of Account Mentioned in the Budget submitted by you, with the proposal, which was sanctioned.
- 8. The account of expenses shall be submitted only through your Institution with the Certificate to the effect that the amount is spent only for the purpose of this Research Project.
- 9. Any unspent amount shall be remitted back to the IUCTE, Regional Institute of Education, Mysuru.

10. Procurement of equipment as per General Financial Rules 2017.

11. In case of non-completion of the Research Project and submission on or before 29-02-2019, or in case of inability to continue and complete the Research Project,

the entire Amount Paid should be returned back to IUCTE, RIEM.

12. No permanent Asset shall be created out of this project Fund however, some tools like Hard disk, pen drive etc., purchased for this project purpose shall become the property Of the Institution and the entry in the asset Register of the

Institution shall be provided to the IUCTE, RIEM.

13. Any books and study materials in print form purchased from this project fund shall be transferred to IUCTE, RIEM to be housed in the Education Resource Centre of IUCTE for the use of all the Institutions/Universities functioning in the

southern States.

14. The appointment of Junior Project Fellow should be made by following

transparent and usual procedure of the Institution/University.

15. JPF is permitted to be engaged only for Three (3) months period, since the Research Project period is only up to 29.02.2019. However, if it is inevitable more than one JPF may be engaged, without exceeding the budget amount sanctioned

for engagement of JPF to complete the Research Project within 29.02.2019.

16. There is a sunset clause imposed in the Project that no liability can lie after 15-03-2020. Hence all the amount payable is to be disbursed to you on or before 29-02-2020 and you shall have to complete and submit the project report accordingly.

17. The acceptance of conditions should be sent through the enclosed draft document, Typed in stamp paper to the minimum value of Rs.80/-, signed in each page and Witnessed by the competent Authority of the Institution, to which you

belong.

18. The stamp paper should be purchased on or after 14-11-2019, in the name of either yourself or in the name of the Principal, Regional Institute of Education,

Mysore.
