

WHEREAS Bharatavani Portal shall include the data/ material in respect of the required topics by using primary and secondary data from the institutions, academicians within India including language related academies, language research institutions, Oriental libraries, Universities, and other language centric academic and research organizations after obtaining "the assignment in any work" or "assignment of copyright in any work" or by obtaining license in any existing "work" or any future "work" from the "author" to use their "work" or material in Bharatavani Portal.

WHEREAS in pursuance of the same **the Assignee** approached the assignor for the acquisition of the assignor's copyright in the above mentioned list of publications as in, which will enable the assignee to publish the same in Bharatavani Portal.

WHREAS the assignor has received a letter from the University Grants Commission (UGC) vide D.O. No. F 1-1/2015 (Secy) Dated 24th November, 2015, requesting all the Universities to share the content with UGC for the purposes of sharing the same with the Bharatavani Portal, and UGC has written a letter to Bharatavani Project (vide D.O.No. F1-1/2016(Secy) Dated 25 January 2016) to follow up this issue with respective Universities and that UGC has written to all Sansrit teaching institutions vide D.O.No. F-1-1/2016(CM) Dated 21st January 2016 to share content with Bharatavani Portal.

Whereas Mysore University has already entered into an Deed of Assignment of Copyright agreement with CIIL with respect to sharing of its encyclopedia volumes and English - Kannada Dictionary on Bharatavani portal and has supported Bharatavani Project and this is in continuation of the earlier agreement.

WHEREAS the said work entitled to be protected under the Provisions of the Indian Copyright Act, 1957 as also under common law principles and hence the assignor agrees to assign the copyright in favor of the assignee for free sharing of the publications with Bharatavani portal in tune with the philosophy of open knowledge culture, for zero cost after mutual discussion and understanding as per the terms and conditions set out below.

THIS DEED NOW WITNESSES AND THE PARTIES HEREIN AGREE AS FOLLOWS:

- The Assignors assigns to the assignee the copyright in the publications as mentioned in the Smt. D. Bharathi, K.A.S, Registrar, University of Mysore Crawford Hall, Mysuru – 570005 KARNATAKA as per the Copyright Act, 1957, limited only to publish in Bharatavani Portal. This Deed of Assignment will not affect the original copyright of the Assignor in any manner whatsoever.
- 2. The assignment shall be valid for India and also for the rest of the world.
- 3. It is further agreed between the parties that notwithstanding the provisions of sections 19 (4) of the Copyright Act, 1957, the Assignment shall not lapse or the right transferred therein will not revert to the assignor, even if the Assignee does not exercise the rights under assignment within a period of one year from the date of this assignment.
- 4. This assignment shall be binding on all legal heirs, successors and assigns of the Assignors and the Assignee.

- 5. The terms of this assignment agreement shall be deemed to take effect from **Thursday 7**th **June 2018**.
- 6. The assignor covenants that the copyright is free and clear from all encumbrances and claims for publishing it on Bharatavani Portal.
- 7. The assignee shall be entitled to hold, own, and use the said copyright exclusively, peaceably and without any interruption by or on behalf of the assignor or by persons claiming under him.
- 8. It is made clear between the parties that the assignee shall not have the right to reassign the copyright in any manner to any person.
- 9. It is specifically understood between the assignor and the assignee that the reproduction of the work in which the copyright was hereby assigned in any material form or in digital form or in the form of a computer programme to facilitate the uploading and publishing in the Bharatavani Portal including the storing of it in the medium by electronic means in the computer hard disk, Computer storage server, etc., will not amount to infringement of copyright.
- 10. It is further understood between the assignor and the assignee that the Assignee will not use the copies in any other manner other than on which the copyright was hereby assigned except publishing it in Bharatavani Portal and electronic platforms based out of Bharatavani Portal.
- 11. The Assignee covenant with the Assignor that the Assignee will bear the full cost of digitization of the above mentioned publications.
- 12. The Assignor will provide soft copies of the approved final print ready files. The Assignor will be provided with a backup of all such materials.
- 13. The Assignee covenant with the Assignor that the Assignee will declare exclusively in the Bharatavani portal that the usage of the published information is governed by Section 52 of the Copyright Act, 1957.
- 14. The Assignee covenant with the Assignor that the Assignee will not make any cinematograph film or sound recording in respect of the work, make any translation of the work and will not make any adaptation of the work except publishing it in Bharatavani Portal; The Assignee can hold such rights under a separate and exclusive MOU, other than this MOU.
- 15. The Assignee covenant with the Assignor that the Assignee will not make any kind of infringement of copyright as enumerated in Section 51 of the Copyright Act, 1957.
- 16. It is specifically understood between the assignor and the assignee that linking the Bharatavani Portal will not amount to infringement of copyright.
- 17. It is specifically understood between the assignor and the assignee that the term "author", "Copyright", "work", "infringement of copyright" which are used in this deed has the same meaning as defined under the Copyright Act, 1957.
- 18. It is specifically understood between the assignor and the assignee that this agreement is governed under the Copyright Act, 1957 except for the terms and conditions set out above.
- 19. It is specifically understood between the assignor and the assignee that the assignor reserves the right to exit from the operation of all or some of the covenants of this deed of Assignment of Copyright at any time of the assignment period, with prior notice to the assignee.
