

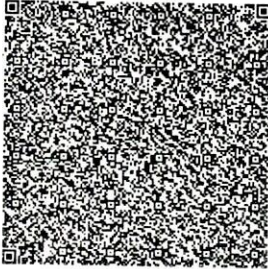

### 1. Participating Bodies

The participating bodies will be the University of Mysore, India and INFOMAPS, Chennai, and will be represented by its faculties and coordinators as specified in **the appendix or appendices**.

### 2. Types of Activities

The areas of cooperation include the following activities:


- Students for internship
- joint projects related to research, teaching, faculty development
- exchange of publications, research materials, newsletters
- conduct of classes on special, relevant subjects of interest
- other relevant and mutually agreed upon activities, which may be specified in an appendix
- recruitment of interns on the basis of merit and suitability for jobs fo different relevant descriptions


### 3. Faculty Member and Student Exchanges

University of Mysore and INFOMAPS agree to send students of Mysore University as interns at the INFOMAPS, further faculties and coordinators to involve in joint projects related to research, teaching and faculty development, and INFOMAPS to conduct classes on special and relevant subjects of specialization for the students of University of Mysore. Such activities are subject to the consent of the relevant faculty/personnel/department at the host institution and to conditions of work cited in writing prior to the program.

The University of Mysore will provide workspace, library, internet and other facilities and assist INFOMAPS in conducting classes while INFOMAPS will do the same for students on internship.

INFOMAPS, Chennai is obliged to provide financial support for interns/students for the period they are with it. Besides, INFOMAPS shall recruit a select number of students, if found qualified, on the basis of their performances at the institution.

#### 4. Effective Date and Length of Agreement
