## This MEMORANDUM OF UNDERSTANDING (hereinafter referred to as "MoU") is made on the 13-02-2019

#### Between

The Ministry of Youth Affairs & Sports, Government of India (hereinafter referred to as "Government")

#### And

University of Mysore, Karnataka (hereinafter referred to as "approved Empanelled Training Institution (ETI)" located at Mysore, Karnataka for imparting training to the Programme Officers of NSS from the State of Karnataka represented by the Registrar of the University/Head of the Empanelled Training Institution (ETIs)

WHEREAS National Service Scheme (NSS) was launched during the birth centenary celebration of Mahatma Gandhi on 24th September 1969 in 37 Universities involving 40,000 students. Today, NSS has more than 38 lakh student volunteers on its roll. NSS is a centrally sector scheme of the Ministry of Youth Affairs and Sports, launched with the objective to develop character and personality of students in schools and colleges. The objective of NSS is to arouse social conscience of the students, and to provide them an opportunity to work with the people in the villages.

University of Mysore, Karnataka, was established on July 27, 1916. It is the sixth oldest in the country and the first in the state of Karnataka. The University is located in Mysuru, the cultural centre of Karnataka. University of Mysore, Karnataka is tapping human resources from all sections of society by offering them opportunities to learn across disciplines, and to build human capital, men and women of character and competence capable of being leaders of tomorrow and solving problems arising out of fast changing realities – global and local. University of Mysore, Karnataka is represented herein by Prof.R.Rajanna, Registrar which expression shall unless repugnant to the context mean and include its successors and assigns of the other

WHEREAS, the Government has decided to recognize University of Mysore, Karnatakaas an approved Empanelled Training Institution for conducting orientation programmes in its campus for the Programme Officers. The parties have had preliminary discussions in this matter and have ascertained areas of broad consensus. The parties now, have therefore, agreed to enter in writing these areas of consensus, under a Memorandum of Understanding.

Now this Memorandum of Understanding witnesses that:

1.0 The University of Mysore, Karnataka (approved ETI) shall offer a schedule of orientation training prégrammes for the Programme Officers of NSS from the State prescribed proforma (given at Annexure-I) for approval of the Government

1.1 The University of Mysore, Karnataka (approved ETI) shall charge the following rates for conducting each training programme of 7 days duration for 35 Programme Officers (The minimum participants should be 30 and the maximum information needs to be shared and prior approval should be obtained from the Directorate of NSS/Ministry).

- The above Course fees of the respective modules may be fixed and revised as and when required by the mutual consent of the Government and University of Mysore, Karnataka(approved ETI).
- The above said training programmes shall be conducted at University of Mysore, Karnataka(approved ETI) on regular basis.

#### 2.0 **PROCEDURE**

The ETIs, after their empanelment by the Government, will submit the approved training calendar for a particular year to the State NSS Officer (SNO) with a copy to NSS Regional Directorate. The programme Schedule along with contents of the course should be shared with the Directorate of NSS, through the NSS Regional Directorate.

Draft Training Schedule is to be shared. Only 10% variation to the Schedule sent by the Directorate of NSS would be accepted.

- The Government will release 75% of the total cost agreed, to the ETIs
- The names and addresses of Programme Officers due for undergoing (d) the orientation shall be finalized by the State NSS Officer (SNO). In the absence of full time/part time SNO, the Regional Directorate (RD) will finalize the list of POs. This list will be submitted by the SNO to the University of Mysore, Karnataka(approved ETI).

SNO will send letters to the respective colleges for relieving the Programme Officers to attend the training. Concerned NSS Regional Directors will ensure the participation of Programme Officers in the training after consulting Programme Coordinator of the concerned area and District Education Officer in case of +2 Programme Officer, in the training organized by University of Mysore, Karnataka(approved ETI)

- (g) The University of Mysore, Karnataka(approved ETI) will submit the audited statement of accounts along with the Utilization Certificate in the prescribed format to the Government. Performance Report, in the (given at Annexure-II) will also be sent by the University of Mysore, Karnataka (approved ETI) to the Government.
- Report, duly counter-signed by the concerned Regional Directorate for each and every training programme will have to be submitted to the Directorate of NSS within a fortnight of completion of the
- A standardized Certificate should be given to the trainees after the completion of the training
- Training should be given to the official within one year of taking over as Programme Officer
- The classes for the above said courses shall be conducted in its campus by the University of Mysore, Karnataka(approved ETI). The course materials shall be provided by the University of Mysore, Karnataka(approved ETI).

#### RESPONSIBILITIES OF APPROVED INSTITUTION EMPANELLED TRAINING

- University of Mysore, Karnataka(approved ETI) shall provide entire infrastructure facilities including classrooms, analytical tools and aids, library, kitchen, dining hall and qualified staff. Also facilities for boarding and lodging of POs, counseling and guidance on courses are to be added as per norms. University of Mysore, Karnataka(approved ETI) shall not at any time for any reasons cause to the Government any situation leading to legal implications.
- The application for empanellment shall be submitted in the prescribed proforma (Annexure-III) by University of Mysore, Karnataka(approved ETI) in consultation with the Government.
- 3.3 University of Mysore, Karnataka(approved ETI) shall appoint qualified and experienced persons as faculty members. List of Empanelled Resource Person should be approved. Empanelled Resource Person should be expert in the subject, either a practitioner, bureaucrat or an academician of repute. The CV of such persons will be furnished to the Government. The Government shall have the right to approve or disapprove the qualifications and experience of the persons appointed by University Karnataka(approved ETI) for handling theory and practical classes. of Mysore,

- 3.4University of Mysore, Karnataka(approved ETI) shall prepare study materials as per guidelines of the Government and obtain the consent of the Government before they are distributed to the participant. The cost of production and distribution of study materials will be borne by University of Mysore, Karnataka(approved ETI).
- 3.5 The internal evaluation as a part of the examination work like classroom tests, assignments, seminars, etc. will be done by University of Mysore, Karnataka (approved ETI) and the reports submitted to the Government periodically.
- 3.6 The expenses in connection with regular lectures, practicals, remuneration to teaching faculty and supporting staff, internal evaluation will be borne by University of Mysore, Karnataka(approved institution) for which 75% advance will be released by the Government as first installment.
- 3.7 The expenses on TA/DA of Officials of University of Mysore, Karnataka(approved ETI) for attending the meetings, held by Government, will be borne by University of Mysore, Karnataka(approved ETI), out of the bank interest accrued on the amount sanctioned by the Government as first installment, as per the norms laid down in FRSR 190 read with clarifications there under by shortest route/entitlement of equated official/officer in the Government.
- 3.8 University of Mysore, Karnataka(approved institution) shall not collect any amount under any head(s) from the Programme Officers joining the course.
- 3.9 No training should be conducted until MoU is renewed.
- 4.0 RESPONSIBILITIES OF THE GOVERNMENT
- 4.1 The Government shall be responsible for prescribing the syllabi of the training module. The suggestions offered by University of Mysore, Karnataka(approved ETI) will be taken into consideration, wherever necessary.
- 4.2 The Government shall monitor the quality of the programmes through persons appointed by it for the purpose.
- 4.3 The Government shall have the right to revise the course fees as and when required in consultation with University of Mysore, Karnataka(approved ETI).
- 4.4 Data bank of trained /untrained Programme Officers will have to be maintained by the concerned Regional Directorates to ensure that all Programme Officers are trained.

5.0 DURATION AND INSPECTION

5.1 This MOU shall be valid for a period from this date and upto 31st March, 2022 and can be renewed for a further period of three years on mutual consent. The Government shall review the progress of the courses each semester. The Government has the right to terminate the contract on the basis of performance and non-submission of Utilization Certificate on time by the University of Mysore, Karnataka(approved ETI)

5.2 In respect of any change in the venue, course, syllabi, eligibility, admissions, collection of fee and fee structure, etc., the decision of the Government is final.

- Any expansion or modification relating to the academic programmes shall be decided jointly by the Government and University of Mysore, Karnataka(approved 6.3
- Any legal implications will be confined to Delhi Jurisdiction only.

#### 7.0 MISCELLANEOUS

- University of Mysore, Karnataka(approved ETI) shall take care of the fulfillment and compliance of the procedural statutory regulations and formalities in connection with the release of funds and its final settlement and the Government will assist the University of Mysore, Karnataka(approved ETI) wherever necessary.
- All the terms and conditions of this MOU are subject to the provisions of the Rules and Regulations of the Government.

THIS MEMORANDUM OF UNDERSTANDING, both parties affirm their commitment to carry out the activities and achieve the objectives mutually agreed upon. Any dispute between the parties shall first be resolved by mutual consultation and any legal implications will be confined to Delhi Jurisdiction only.
