- iii. The grantee organization should submit 10 copies of the report of the proceedings and press release, if any, and other documents as indicated in Para 3(ii) above to the National Commission for Women on a prescribed format along with its soft copy.
- iv. It is mandatory to display 'Organized by Centre for Study of Social Exclusion and Inclusive Policy, Humanities Block, Manasgangothri, Mysore, Karnataka-570006 with the support of National Commission for Women' with date and venue at a prominent place on the dais and also at the cover page of the report of the seminar.
- v. The amount will be spent for the purpose for which it has been sanctioned and no portion thereof will be utilized for any other purpose. No equipment or asset will be purchased out of the assistance.
- vi. The sanctioned amount will not be exceeded under any circumstances and any portion of the assistance remaining unutilized will be refunded to the Commission.

Proceedings of the Two Day National Seminar on "Women Entrepreneurship and Skill Development: Issues, Challenges and Opportunities" held on 9th and 10th January 2020 at University of Mysore, Mysore, Karnataka.

BACKGROUND

With the new policy of liberalization, globalization and privatization, India's economy has witnessed drastic changes since mid-1991. India has huge entrepreneurial potential. The concepts of entrepreneurship and skills are interrelated. Skills are basic, but not enough, to get decent jobs. Enhanced productivity through skill development must be complemented by economic growth and employment. Overall, they are a prerequisite for the government's pursuit of comprehensive development of the nation. Entrepreneurship is traditionally defined as the process of designing, launching and running a new business, which usually begins as a small business, such as a startup company, offering a product, process or service for sale or hire. Entrepreneurship development is the process of improving the skills and knowledge of entrepreneurs and enhancing their ability to develop, manage and organize marketing by considering the risks involved.

Entrepreneurship is crucial to the overall development of any nation and in recent years it has gained prominence with the participation of women. Women today are more progressive and play an important role in meeting their economic needs and achieving social status. The emergence of women entrepreneurs in society depends mainly on changing social, psychological, economic, and cultural dimensions, which has a positive impact on the economic participation of any developed and developing countries. In India, women play an important role in society, but their entrepreneurial potential is not recognized due to the low level of women in society. It is necessary to change the mindset of women to give equal rights as defined in the Constitution.

Women entrepreneurs are defined as those who manage and control the industry, and their industry accounts for at least 51 percent. They represent a group of women who are not on the path to be defeated and explore new ventures of economic participation. "Women Entrepreneurship" is a function of business ownership and business creation that empowers and empowers women and empowers them in society. Women-entrepreneurs have a lot of influence in all sectors of the economy. A "woman entrepreneur" is a person who denies the role of their individual needs to participate and receive financially independent. The strong desire to do something positive is a high-quality women entrepreneur contributing to the values of family and social life. Now there are various factors that motivate her as women enter the field of entrepreneurship. These factors include education, the desire to be independent, the desire to make money, and to make a mark in society.

Significance of the Seminar

Currently, women's participation in economic activities is marked by lower work participation rates. Women entrepreneurship has accelerated over the last three decades with the increase in the number of women entrepreneurs and their

contribution to economic growth. In this dynamic world, women entrepreneurs are an important part of economic development and social progress. Being in business line for about 12 years till date, she had experienced several challenges despite the family support. However, in the process she learnt the art of time management and money management, which according to her are mandatory for being successful in business. To her, women entrepreneurship was the need of the hour. She stressed that girls and women must avail the existing opportunities available. Women entrepreneurs do have several hurdles in the family but should never be taken negatively as "suffering". They should rather overcome them. She concluded mentioning that skill development is a must for initiating a business unit.

Prof. Chaya K Degaonkar initiated her keynote address that gender sensitization was necessary to change the mind set of the people, both men and women in the society on women entrepreneurship. The sustainable development goal # 5 on gender equality was the focus of her presentation. To her, empowerment meant economic empowerment i.e. control over resources and make her independent. The other hindrance in the society was the patriarchal system and the masculine thinking i.e. "he"instead of "him / her". The mindset among the people is that "she" is not capable of controlling resources or taking decisions. This change in mindset has to come about in the society. Similarly, there is no value given to the domestic work carried out by women at home. There is a proposal put up for the 2021 census to include domestic work carried out by women at home. There is a proposal also to include gender accounting in the GDP.

Dr. Degaonkar mentioned that for over a couple of decades, women in business is limited to 3Ps (pickle, papad and powders) and rather should change to 3Es (electronics, e-commerce and e-business). Across the world, out of 147 countries, India ranks #142 in terms of gender equality in work force and women's monetary contribution. Currently the monetary contribution of women in India is \$ 0.7 trillion US. It is observed that with increase in technology, there is marginalisation of women occurring i.e. reduction in employability of women. Thus, there is a need to increase the employability among women through skill training. Dr. Chaya discussed the concept of entrepreneurship and the schemes and programmes available at the state and central level such as EDP, STEP and other such schemes. She stressed that there is a gender audit conducted by the government of their schemes and programmes. For instance, Udyogini scheme has shown good results.

Dr. Degaonkar mentioned about the barriers faced by the women running business units, especially in mobility and networking which is crucial for successful business. With regard to skills, she opined that there are lacks of skill providers in the country especially soft skills – like communication skill. Dr. Chaya concluded her presentation with the observation that India would be a leader in providing skill training, and the central government has taken up this as its flagship programme. In all, every person is an entrepreneur in what ever field / profession they have chosen.

Mr. N S Shivanna, District Skill Development Officer, Department of Skill Development Entrepreneurship and Livelihood, Mysore, Govt of Karnataka, focussed on the skill training scenario in Karnataka state. He mentioned that it was government's objective of providing skill training to fulfil the needs of the industrial sector. As a part of the skill training, 400 hours of training (theory and practical) is imparted. Later there is an evaluation and certificate is provided to the candidates. The package also includes placements that range from 40 per cent to 70 per cent each year. However, the employability of the students is less than 50 per cent as there is a gap between the training curriculum and the needs of the industry. Mr. Shivanna expressed that there is a need to focus on competency, confidence and adaptability. After 1992 and LPG, employment growth has taken place in the country significantly. The NULM and NRLM programmes have facilitated employment, especially for women.

To improve the work participation rate of women, the focus has to be on 4Es i.e. education, employability, empowerment, and entrepreneurship. Role of parents and other family members is vital to women's effective participation. Comparatively the service sector has more scope for women's participation than other sectors. Though lending rates have reduced overtime, cost of starting a business unit have increased. Hence the response from women is low. Mr. Shivanna concluded with the remarks that for women to be successful entrepreneur, she must understand her own strengths and improve problem solving skills that include managerial skills, HR skills, and technical skills.

Panel Discussion and Summing Up

The panel discussion was chaired by **Prof. M Indira**, Professor of Economics, University of Mysore, Mysuru. Panel members included **Dr. Ramesh**, Professor of Law, University of Mysore, Mysuru, **Prof. S Mahendrakumar**, Chairman, DOS in Economics and Cooperation, University of Mysore, Mysuru, **Prof. MR Ganghadhar**, Chairman, DOS in Anthropology, University of Mysore, Mysuru and **Dr.Ananth S Panth**, Team Consultant, Kalyana Bhavan, Dept of Social Welfare, Govt. of Karnataka. **Dr. Siddaraju V.G**, Seminar Organizing Secretary and Associate Professor, Centre for study of Social Exclusion and Inclusive Policy, University of Mysore, Mysore was delivered the seminar proceedings and major issues sheared and discussed by the resource persons and recommendations made during the seminar.

Major Issues Shared and Discussed By the Resource Persons during the Seminar:

- An attempt has been made to know the role of entrepreneurship and skill development in empowering the women. Skill development is found to be the key to improving household productivity, employability and income earning opportunities for women and also for enhancing food security and promoting environmentally sustainable rural development and livelihoods. The study also shows that skill development increased economic independence among rural women.
- The paper discusses about the women entrepreneurs' contribution towards nation development and their comparison with global market. Women entrepreneurship is gaining importance in India in the wake of economic liberalization and globalization. The policy and institutional framework for developing entrepreneurial skills, providing vocation education and training has widened the horizon for economic empowerment of women.
- A study on the status of women entrepreneurship in the study area, to analyse the problems faced by women entrepreneurs in development of economic activities in the study area in Nanjangud finds that successful women entrepreneurs are model for next generation women entrepreneurs.
- Akshaya programme implemented in Kerala state, is an E-Governance programme with e-literacy as its objective. The study identifies the

dimensions of empowerment and challenges faced by the women entrepreneurs of *Akshya* Project. The highlights were that there are 2735 E-Kendras currently of which 1227 e-kendras are run by women. The target is to reach a total of 5000 e-kendras. Initially there was one kendra set up for every 2 k.m. distance. It was not economically viable, hence reduced it to two centres per grama panchayat.

- The analysis of ownership of enterprises by urban –rural sector, social groups and religion, using 6th economic census data. UNDP human development report mentioned the co-relationship between Gender Development Index and Human Development Index. But in the globalization growth scenario entrepreneurship became the driver of the women's economic development.
- A study on the retail entrepreneurs belonging to scheduled caste, recognize key competencies in rural area of Bengaluru and Mysuru district. The study infers that though some of the skills may be innate but most of the entrepreneurial competencies are extensively spread across different social groups. Further scheduled caste women entrepreneurs possess advanced attitudinal and behavioral competencies, but due to a low range of managerial competencies the appearance and venture start-up ratios among these communities maybe deficient behind their counterpart in India.
- The paper aims to explore various skill development programmes provided by RUDSET Institution of Dharmasthala in Mysore and also tries to assess the effectiveness of skill development programs given to the women entrepreneurs by the institution and comparison of women entrepreneurs with and without training. The study concludes, there exists relation between skill development programmes and financial upliftment of women entrepreneurs.
- Impact of microfinance on women empowerment concludes that the micro insurance can be an effective tool in protecting and promoting health among rural poor in the study area with the help of self -help groups and its members. The awareness raising is an important prerequisite for voluntary uptake of various micro insurance schemes and that interactive, contextualised awareness tools are useful in enhancing insurance understanding.
- Role of the microfinance institution named Ujjivan. They presented four success stories highlighting that it has created a very professional system in

account keeping, This paper explains about, what kind of unique problems are faced by women as an entrepreneur, and how to overcome those problems, what solution makes them to be a successful women entrepreneur. What are future ambitions and what factors lead to their stress.

- Digital inequality in terms access of internet in Odisha shows that marginalized section of the society are excluded from the mainstream technological opportunity in the name of skill.
- Economic factors and social factors affecting personal empowerment of women through microfinance institutions in Mysore District. Women entrepreneurs already registered in Stree Deepa Women Training and Production Unit (SDWTPU). The study results show that majority of respondents opined that microfinance institutions are definitely helps to economically, socially and personally empowerment of women is the main aim of microfinance, which leads to sustainable development of the nation.
- The role of Jnanavikas Kendra in developing skills to SKDRDP SHG'S and rural women and participate in economic activities as entrepreneurs. It brings out the effective paths to achieve women empowerment by crossing hurdles of rural areas.
- The case study of the success story of Ahallyabai Self Help Group (SHG) of Gaddankeri, Bagalkot District provides conceptual clarity of empowerment and Self-Help Group, the measuring tools of skill development and empowerment, It is observed that the SHG strategies have positively contributed for the skill development of women and the strategy of SHGs are an ideal and indispensable tool of women's empowerment.
- MGNREGP in Kerala which entitles rural households to 150 days of casual employment on public works at the statutory minimum wage has opened up a new opportunity for women workers. As it is locally available, regular and predictable in working hours and socially acceptable.
- The concept of 'Co-Working Space', appropriate for IT enabled service oriented businesses, such as E-commerce was discussed. The co-working space includes providing a table and a chair with Wi-Fi facility and a meeting hall for 8-10 persons. Hence, there would be no fixed investment, but, only working capital at Rs.300 per chair.
- The programme on technology transfer and business development related to food processing at CFTRI provides free technology on various types food

processing and access to related machinery. It takes up training to farmers and cluster development activities to create 'technical villages' for village empowerment. They can be contacted on ttbd@cftri.res.in. Additional information can be had from their website www.cftri.com/ttbd.

• The views focused on women empowerment with special reference to higher educational institutions and their contribution to nation's economic growth. The argument is that a knowledge-driven economy demands a larger proportion of the skilled work force in order to meet the present market demands. It is highlighted that innovation and creativity is very important in every field. The example of "Glass Ceiling Effect" with reference to women empowerment and that woman should overcome this effect.

Major Recommendations made during the Seminar

- Barriers in women entrepreneurship include social and cultural barriers, financial barriers, and access to raw materials. Support provided to women including technology, financial and marketing will motivate women entrepreneurship to a great extent.
- There is a need to create awareness about various entrepreneur and skill development programmes particularly for the rural women, youth and marginalized groups;
- There is a need to create skill development centres focusing traditional sectors at each taluk and village level in the country to encourage more number of women to take up entrepreneurship confidently;
- There is a need to expand training institutes mainly in the remote areas of the country and also need to develop infrastructure suited for women and to make ITIs more accessible to women. Besides that there is a need to expand training provisions for marginalized sections, rural women, youth and rural poor.
- It is suggested that vocational education should be introduced the level of secondary education onwards, to attract students who may drop out, to train them and as a result provide them with better livelihood opportunities.
- There is an urgent need of combined efforts with local NGO's and Panchayats to increase enrolment of women in vocational education and training and also

to create awareness for women and their families on the advantages of vocational education.

- Training centre must provide an advance level of training on par with the market demand.
- CFTRI, Mysore has created a big platform especially for women to take up entrepreneurship in food processing by providing technology in food processing, access to machinery and other services to set up a food processing unit.
- PMKVY and national Skill Development Corporation of India have played a key role in facilitating training women several trades and building their capacity for wage employment and self employment.
- RUDSETI has been in forefront among training institutions for training women in several trades by empowering them with technical and entrepreneurial skills to take up wage employment and self-employment.
- Skill development training imparted to women has resulted in improvement of their standards of living.
- MNREGS and Kudumbashree Programme in Kerala have provided financial empowerment to over 80 per cent of women beneficiaries, especially the unmarried and disabled women.
- The SHG concept has been successful in empowering women especially the casual workers and agricultural workers.
- By and large, tourism has facilitated in motivating women entrepreneurship in hospitality sector.
- Family support and legal support are crucial for women entrepreneurship.
- Better education and personality development will enhance women entrepreneurship
- Entrepreneurship is shown to be one of the important methods of empowering women in terms of decision making process and access to resources.

Finally, Dr.Nanjunda DC, Associate Professor, CSSEIP, University of Mysore, Mysuru extended Vote of Thanks to the panelists for their appropriate interventions, the paper presenters for their research output and all the delegates for making the seminar, a successful event.
