I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the **June 2020 National Eligibility Test (UGC-NET)**, you have been selected for award of fellowship under the scheme of 'National Fellowship for Scheduled Caste Students' for the year 2020-21 (June Cycle).

The tenure of the Fellowship is five years and it commences from the date of declaration of result for NFSC i.e. **30.11.2020** (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

As per information provided by you while applying online for UGC-NET, you have not taken admission for M.Phil/Ph.D. Accordingly, you are required to get admission and registration for regular and full time M.Phil/Ph.D. course in a University/Institution recognized by UGC at the first-available opportunity but not later than three years from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of the Scheme and Notification dated **17.12.2020**. The same can be accessed at https://www.ugc.ac.in/ugc_notices.aspx.

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on <https://ugcnet.nta.nic.in>. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.

Pursuant to the approval of the Vice-Chancellor Mr. Pradeepkumar H.K. S/o Kunnanjaiah, New Street, Honganur Village and Post, Chamarajanagar Taluk & District, Karnataka-571 117, is awarded the National Fellowship for SC Candidate (UGC-NET) for the year 2020-21 in Humanities and Social Science. The National Fellowship for SC is tenable for five years subject to the satisfactory progress report of the fellow. He is eligible to draw Rs. 31,000/- per month for first two years and Rs. 35,000/- per month for next three years. He shall work on the research topic "EFFECT OF GAMIFICATION TECHNIQUE OF TEACHING SCIENCE ON SCIENCE LITERACY, SCIENTIFIC ATTITUDE AND SCIENTIFIC CREATIVITY OF SECONDARY SCHOOL STUDENTS" under the guidance of Dr. G. Sheela, Associate Professor, DOS in Education, Manasagangotri, Mysore, He is entitled to an Annual Contingency Grant of Rs. 10,000/- per annum for initial two years and Rs. 20,500/- per annum for remaining three years as per rules in force. He shall utilize the grant with the prior permission from the Chairman, DOS in Education, Manasagangotri, Mysore and also on the recommendation of the guide on each occasion and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

He should report himself for duty to the Chairman, DOS in Education, Manasagangotri, Mysore within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 30.11.2020 or the date of joining whichever is later.


The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier,

He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the original certificates of qualifications, age and date of birth before **Chairman, DOS in Education, Manasagangotri, Mysore** for verification and return, and award of the National Fellowship for SC is subject to the conditions stipulated in the Comprehensive Ordinance and UGC guidelines issued from time to time for award of the Fellowship.

Regarding Payment of fellowship amount the awardee is required to follow the instructions given in the award letter.



