He should report himself for duty to the Director, Kuvempu Institute of Kannada Studies, Manasagangothri, University of Mysore within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 2019-20 or from the date of registration under Ph.D or from the date of joining in Ph.D Programme, whichever is later.

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D thesis whichever is earlier. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the original certificates of qualifications, age and date of birth before Director, Kuvempu Institute of Kannada Studies, Manasagangothri, University of Mysore for verification and return.
