Pursuant to the approval of the Vice-Chancellor, Mr. Mahesha M. s/o Madanaika., Kallahalli Keri, Kalale Village and Post, Nanjangud Taluk, Mysore District -571118, Karnataka is awarded the National Fellowship for Higher Education of ST Students for the year 2019-20 in Humanities & Social Sciences, The National Fellowship for Higher Education is tenable for five years subject to the satisfactory progress report of the fellow he is eligible to draw Rs. 28,000/- per month he shall work on the research topic "KALALE GRAMA: SAMSKRUTHIKA ADHYAYANA" under the guidance of Dr. N.M. Talawar, Professor, Kuvempu Institute of Kannada Studies, Manasagangotri, Mysore.

He is entitled to an Annual Contingency Grant of Rs. 20,500/- per annum as per rules in force. he shall utilize the grant with the prior permission from the Director, Kuvempu Institute of Kannada Studies, Manasagangotri, University of Mysore, Mysore and also on the recommendation of the guide on each occasion and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion, Further as per rules, he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

He should report himself for duty to the Director, Kuvempu Institute of Kannada Studies, Manasagangotri, University of Mysore within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 2019-20 or from the date of registration under Ph.D or from the date of joining in Ph.D Programme, whichever is later.



The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D thesis whichever is earlier. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the original certificates of qualifications, age and date of birth before **Director, Kuvempu Institute of Kannada Studies, Manasagangothri, University of Mysore** for verification and return. And Award of the National Fellowship for Higher Education (NFST) is subject to the conditions stipulated in the Comprehensive Ordinance and Ministry of Tribal affairs guidelines issued from time to time for award of the National Fellowship for Higher Education (NFST).

Regarding payment of fellowship amount the awardee is required to follow the instructions given in the award letter.



