Dear Candidate,

I am pleased to inform you that you have qualified for Junior Research Fellowship (JRF) and Eligibility for Assistant Professor in the Joint CSIR-UGC Test conducted on 16th December, 2018. The tenure of fellowship is five years and it commences from the date of declaration of NET result, i.e., 2nd April 2019 (or) from the date of admission under M.Phil/Ph.D. (or) from the date of joining M.Phil/Ph.D. programme, whichever is later. The summary of financial assistance offered under the scheme is mentioned at **Annexure I** available on www.ugc.ac.in/netjrf along with other Annexures.

The Awardee is required to get admission and registration for regular and full time **M.Phil/Ph.D.** course in a University/Institution/College recognized by UGC at the first available opportunity **but not later than three years** from the date of issue of this award letter. University/Institution/College is requested to process for award of JRF based on this letter, in accordance with procedure available on www.ugc.ac.in/netjrf.

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the Awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities / Colleges / Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker / Checker Ids which have already been provided to them along with the passwords. The Universities / Colleges / Institutions shall update the information in the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities / Colleges / Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).


It may also be noted that UGC has proposed to link "AADHAAR" with bank account of students so that there can be direct cash transfer and effective disbursement of fellowship into bank account of the student. In this regard, Secretary, UGC had requested the universities to help students in Aadhaar enrolment vide D.O. No. F.14-34/2011 (CPP-II) dated 11.01.2013.

It may please be noted that the award is liable to be cancelled by Implementing/Awarding agency and it will also attract legal action against the Awardee in the following cases:

- (i) If the awardee is found to be ineligible to receive the award at any point during the entire duration of fellowship,
- (ii) Misconduct of Awardee,
- (iii) Unsatisfactory progress of research work,
- (iv) Failure in any examination related to M.Phil/ Ph.D,
- (v) In case, any other fellowship is drawn from other source(s),
- (vi) Concealment of facts.

The E-certificate of Eligibility for Assistant Professor has already been uploaded on www.ugcnetonline.in. The eligibility of the candidate is to be ensured by the concerned institution/appointing authority. The category under which the candidate had appeared may be got verified from UGC.



1. The Doctoral Candidates should conduct research for a minimum period of 03 years and maximum period of 6 years from the date of provisional registration as per the 8.1(a) Ph.D Regulation 2017.
2. The Ph.D registration is valid for a period of 6 years from the date of provisional registration and it is extendable by one more year on request by the candidate well in advance with a recommendation of the Guide and Director/Chairperson of the Institute/Department followed by approval of Vice-Chancellor on payment of the prescribed fee.
3. The candidate should submit progress reports certified by the Guide and Director/Chairperson of the Institute/ Department with the fee paid challan in every year. If the candidate fails to submit two Consecutive Progress Reports in time, it amounts to cancellation of the Registration, and this shall be notified by the Registrar(Evaluation). For any reason the fee paid, will not be reimbursed to the researcher.
4. While submitting the progress report **Tuition fee, Processing fee and Laboratory fee** has to be paid to the Examination Account and the Challan should be enclosed.
5. Examination fee has to be paid to the Examination Account of the University and the Challan has to be furnished at the time of submission of Final Synopsis and Thesis.
6. The Research candidate shall strictly adhere to the Regulation mentioned above.
7. On completion of research work, 10 copies of synopsis and 4 copies of thesis, an electronic version of the thesis, evidence of two research publications, prescribed application form for submission of thesis and synopsis, challan for having paid the examination fee, declaration signed by the candidate and certified by the guide for having prepared the thesis, No Due Certificates from the Department, Library and the Hostel should be submitted through the guide and the Director/Chairperson of the Institution/Department. Details of payable fee can be obtained from the Office of the Directorate of Research, Pareeksha Bhavan, University of Mysore, Mysuru, during office hours.
8. If candidate fails to submit the thesis even after 7 years i.e after getting one year of extension period, the Ph.D registration in the respective subject stands automatically cancelled.

Pursuant to the approval of the Hon'ble Vice-Chancellor, Ms.Pushpa.K, D/o Krishnan.R, #129, K.S.C.B Colony, Kalyanagiri Nagar, Opposite to J.S.S High School, Rajkumar Road, Mysuru is awarded the UGC-JRF in **Mathematical Sciences** on a Fellowship value of **Rs.31,000/-** per month initially for a period of two years. She shall work on the research topic "**A WALK THROUGH THE WORKS OF RAMANUJAN**" under the guidance of Dr. K.R.Vasuki, Professor, Department of Studies in Mathematics, Manasagangothri, University of Mysore, Mysuru.

She is entitled to get an Annual Contingency Grant of Rs.10,000/- as per rules in force. She shall utilize this grant with the prior permission from the Chairman, Department of Studies in Mathematics, Manasagangothri, University of Mysore, Mysuru and also on the recommendation of the guide seeking permission for the subsequent occasion. Further, as per rules, she is entitled to draw House Rent Allowance at the rate of **16%** of the fellowship amount. She should report herself for duty to the Chairman, Department of Studies in Mathematics, Manasagangothri, University of Mysore, Mysuru within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled.

The tenure of fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the fellow will be evaluated by experts. If the research work is found satisfactory, her tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF).


In case, the work for the first two years is not found satisfactory, an additional year will be given to him for improvement. However, during this period she will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years, and if improvement is found, the Fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, and there will be no further provision for extension.

The fellowship will be effective from **20-04-2019** or date of Joining of Ph.D research whichever is later. She should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, she is required to produce all the Original Certificates of qualifications, age and date of birth before the Chairman, Department of Studies in Mathematics, Manasagangothri, University of Mysore, Mysuru.

Award of this UGC Junior Research Fellowship is subject to the conditions stipulated in the Comprehensive Ordinance and UGC Guidelines issued from time to time for award of the Research Fellowship. Regarding uploading the documents related to the payment of fellowship, she is directed to approach the ICD Office, Department of Studies in Computer Science, Manasagangothri, University of Mysore, Mysuru.
