Pursuant to the approval of the Vice-Chancellor, Mr. Madhuprasad K.S. s/o Shantharaju M., Hosa Kukuru Village and Post, Talakadu Hobli, T. Narasipura Taluk, Mysore District -571122, Karnataka is awarded the National Fellowship for Higher Education of ST Students for the year 2019-20 in Humanities & Social Sciences, The National Fellowship for Higher Education is tenable for five years subject to the satisfactory progress report of the fellow he is eligible to draw Rs. 28,000/- per month he shall work on the research topic "AN EMPIRICAL ANALYSIS OF SUSTAINABLE TRANSPORT SYSTEM : WITH SPECIAL REFERENCE TO MYSURU CITY" under the guidance of Dr. Premakumara G.S, Professor, Dept. of Economics, Sir M.V. Post Graduate Centre, Mandya.

He is entitled to an Annual Contingency Grant of Rs. 20,500/- per annum as per rules in force. he shall utilize the grant with the prior permission from the Director, Sir M.V. Post Graduate Centre, Mandya. and also on the recommendation of the guide on each occasion and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion, Further as per rules, he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

He should report himself for duty to the Director, Sir M.V. Post Graduate Centre, Mandya. within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. The fellowship will be effect from 2019-20 or from the date of registration under Ph.D or from the date of joining in Ph.D Programme, whichever is later.


The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D thesis whichever is earlier. He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.



- The Candidate has instructed to attend the Ph.D Course work next conducted.


