Pursuant to the approval of the Vice-Chancellor **Mr. Shashikumar S/o Shankarappa, AT Mattur Tanda, Mattur Post, Raichur, Karnataka - 584 125**, is awarded the National Fellowship for SC Candidate (UGC- NET) for the year **2020-21 in Humanities and Social Science**. The National Fellowship for SC is tenable for five years subject to the satisfactory progress report of the fellow. He is eligible to draw **Rs. 31,000/-** per month for first two years and **Rs. 35,000/-** per month for next three years. He shall work on the research topic **"KARNATAKA LAMBANIGARA SAAMAJIKA MATTU RAJAKIYA SABALIKARANA: VISHESHAVAGI RAICHUR JILLEGE SAMBANDHISIDANTE ONDU ADHYAYANA"** under the guidance of **Dr. Midatala Rani, Professor, DOS in Political Science, Manasagangotri, Mysuru**, He is entitled to an Annual Contingency Grant of **Rs. 10,000/-** per annum for initial two years and **Rs. 20,500/-** per annum for remaining three years as per rules in force. He shall utilize the grant with the prior permission from the **Chairman, DOS in Political Science, Manasagangotri, Mysuru** and also on the recommendation of the guide on each occasion and he shall furnish the details of amounts drawn during previous occasions while seeking permission for the subsequent occasion. Further as per rules he entitled to draw House Rent Allowance at the rate of 16% of the fellowship amount.

He should report himself for duty to the **DOS in Political Science, Manasagangotri, Mysuru** within a period of one week from the date of receipt of this order, failing which the award will be treated as cancelled and disposed of otherwise. **The fellowship will be effect from 30.11.2020 or the date of joining whichever is later.**

The fellowship is tenable for five years subject to satisfactory progress report of the fellow or submission of Ph.D. thesis whichever is earlier,



He should give a declaration at the time of reporting to duty and the same shall be forwarded to the University.

At the time of joining duty, he is required to produce all the original certificates of qualifications, age and date of birth before **DOS in Political Science, Manasagangotri, Mysuru** for verification and return, and award of the National Fellowship for SC is subject to the conditions stipulated in the Comprehensive Ordinance and UGC guidelines issued from time to time for award of the Fellowship.

Regarding Payment of fellowship amount the awardee is required to follow the instructions given in the award letter.




