This in pursuance of the MHA's approval vide O.M. No.23011/133/2018-PT, dated 28.08.2019, IFA's approval vide Note 13, dated 21.07.2020 and DG, BPR&D's approval vide Note 14, dated 21.07.2020, regarding expenditure sanction of Rs.52,17,300/- (Rupees Fifty Two Lakhs Seventeen Thousand and Three hundred Only) for carrying our three research projects approved by the Standing Committee on Police Research headed by the Home Secretary.

2. The sanction of the Competent Authority is hereby conveyed for incurring an expenditure of Rs. 19,00,500/- (Rupees Nineteen Lakhs and Five Hundred Only), to the Registrar, University of Mysore, Karnataka for undertaking research study on "Children's Homes under the Juvenile Justice (Care & Protection) Act 2015: Status & Measures to Improve". The Project Director of the research study will be Dr. D.C. Nanjunda, Associate Professor cum Dy. Director, Centre for the Study of Social Exclusion and Inclusive Policy, University of Mysore, Karnataka. The duration of the project is 15 months.

3. The objectives of the study are as follows:

- To conduct an in-depth study of the status of the structural, organizational and operational framework of the children's' homes as envisaged in the Juvenile Justice (Care and Protection) Act 2015;
- To identify the gaps and lacunas in implementation of the juvenile justice (Care and Protection) Act 2015 in the context of the infrastructure and service in the children's' homes and to identify the reasons thereof;
- To suggest measures for improvement of infrastructure and services in children's' homes in order to comply with the provisions the juvenile justice (Care and Protection) Act 2015

4. The funds will be released in three equal instalments. The 33% of amount, i.e., Rs.6,33,500/- (Rupees Six Lakhs Thirty Three Thousand and Five Hundred Only) out of the total approved amount of Rs.19,00,500/- (Rupees Nineteen Lakhs and Five Hundred Only) is hereby released to the Registrar, University of Mysore, Karnataka as the first instalment, for the commencement of the aforesaid research study. A copy of MoU signed between the BPR&D and Registrar, University of Mysore, Karnataka for the research study is enclosed as Annexure - 1.

5. The remaining 67% of amount, i.e., Rs.12,67,000/- (Rupees Twelve Lakhs Sixty Seven Thousand Only), will be released in two equal instalments. The second instalment will be released subject to the satisfaction of the DG, BPR&D regarding the progress of the project and

the final instalment will be released only after satisfactory completion of the project and submission of the project report and Utilization Certificate to the BPR&D.


6. The sanction is further subject to the following conditions and its approval by the DG, BPR&D:

- a. The amount shall be utilised for the purpose for which it has been released.
- b. The grantee is not permitted to divert the grant for any other purpose. If after, having received the grant, the grantee is not in a position to execute or complete the project, the entire amount of the grant received with interest thereupon will be returned forthwith to this Bureau.
- c. Any amount of the grant, which is not spent for the purpose for which it is sanctioned, should be refunded forthwith to this Bureau.
- d. A Utilization Certificate for the full amount of the grant received shall be submitted to this Bureau. An audited statement showing expenditure met out of this grant will also be furnished along with the Utilization Certificate.
- e. 10 hard copies of the report along with the soft copy of the report should be submitted to the BPR&D.
- f. Executive Summary of the study should be submitted at the time of submission of the final research study report.
