On completion of research work, 10 copies of synopsis and 4 copies of thesis, an electronic version of the thesis, evidence of two research publications, prescribed application form for submission of thesis and synopsis, challan for having paid the examination fee, declaration signed by the candidate and certified by the guide for having prepared the thesis, No Due Certificates from the Department, Library and the Hostel should be submitted through the guide and the Director/Chairperson of the Institution/Department.
