Prof.B.Mahadevappa has thirty-seven years of experience - twenty-four years post graduate teaching experience; six years under graduate teaching experience; and seven years administrative experience in the Central Board For Workers Education, Ministry of Labour, Government of India. He has been for five years as Finance Officer in the University of Mysore; for three years as Director, University Industry Interaction Centre of University of Mysore; and for one year as Director, Post Graduate Centre, Hassan. Currently, he is the Dean, Faculty of Commerce and Chairman, Board of Studies in Commerce of University of Mysore.

He was born on 1963 at Keralapura in Hassan District. He received his Master's degree in Commerce at the University of Mysore in 1986 with second rank; and the degree Doctor of Philosophy at University of Mysore in 2001. He was a Post-Doctoral Research Fellow of University Grants Commission for three years. He was instrumental in upgrading Department of Studies in Commerce as UGC SAP Department at DRS-I level with Fifty-five lakh UGC grant as Deputy Co-Ordinator. He organized One Week "Global Initiative for Academic Network (GIAN)" Programme of Government of India with grant amount of Five lakh on "Extensible Business Reporting Language" in collaboration with University of Kansas, USA.

As a researcher, he has guided thirteen research scholars for their Ph.D. degree in Commerce. Research studies that he is working on now or have recently finished include application of total quality management practices in manufacturing and service industries, evaluation of accounting practices of non-profit organizations, studies on social accounting, value added accounting, accounting for price level adjustments, extensible business reporting language, international financial reporting standards and Indian accounting standards.

He has partnered with Confederation of Indian Industry and NASSCOM and enabled university-industry interaction. He conducted more than twenty-five University-Industry Interaction Programmes in collaboration with Confederation of Indian Industry and NASSCOM.

He is the author of sixty-two research papers with 401 Citations, h-index of 5 and i10 Index of 5. He has presented eighty-six research papers in national and international conferences and seminars. He delivered more than one hundred lectures as Resource Person. He organized more than twenty seminars and conferences. He visited Australia, Taiwan and Thailand to present research papers in the international conferences held during 2012, 2009 and 2006.

He was a member of Academic Council, and Member Secretary of Finance Committee of University of Mysore for five years. He has been a member of Faculty of Commerce, Board of Studies of Commerce and Board of Examiners of several universities and autonomous colleges. He was a member of State Level Text Book Revision Committee of DSERT, Government of Karnataka under National Curriculum Framework.
