- 1. The eligible candidates can download the application form at <a href="http://www.uni-mysore.ac.in/english-version/sites/default/files/content/odl\_applicationform\_2018-19.pdf">http://www.uni-mysore.ac.in/english-version/sites/default/files/content/odl\_applicationform\_2018-19.pdf</a> and the filled in application along with a DD of Rs. 400/- drawn in favor of Finance Officer, University of Mysore, Mysuru shall be submitted to the Office of the Director, Directorate of Distance Education, National Centre for History of Science Building, Manasagangothri, Mysuru 570006 on or before 20<sup>th</sup> October 2018.
- 2. The application should be enclosed with the self attested copies of the relevant documents (<a href="http://www.uni-mysore.ac.in/english-version/sites/default/files/content/odl\_enclosures.pdf">http://www.uni-mysore.ac.in/english-version/sites/default/files/content/odl\_enclosures.pdf</a> ).
- **3.** At the time of application submission, candidates have to produce all original documents for verification. The candidates found to be eligible for admission by the respective selection committee can get admitted by paying the prescribed fee to the general revenue account number **54007591471** on or before **20-10-2018**.
- **4.** Immediately after paying the prescribed fee, the candidates should enroll for the program at the office of the Director, Directorate of Distance Education.
- 5. The candidates who wish to submit an application through postal services have to send the duly filled application form along with self attested copies of all relevant documents (<a href="http://www.uni-mysore.ac.in/english-version/sites/default/files/content/odl\_enclosures.pdf">http://www.uni-mysore.ac.in/english-version/sites/default/files/content/odl\_enclosures.pdf</a>) and a DD of Rs. 400/- towards Application fee and a separate DD for the prescribed fee for the programme. These candidates are provisionally admitted. However, they are required to get the admission confirmed by producing the original copies of the documents during period of contact programs. Otherwise, their provisional admission is liable to be forfeited.
