**STATUTES RELATING TO ESTABLISHMENT OF BABU JAGAJIVANRAM CHAIR IN THE UNIVERSITY OF MYSORE, 2000**

(framed as per the Provisions of Sec. 23 (2)(h) read with Section 35 (n) of KSU Act, 1976)

**PREAMBLE AND JUSTIFICATION:**

India has produced some great thinkers and social leaders who by their revolutionary and path breaking thoughts and actions have left a lasting impact on other people. They have propounded thoughts and initiated actions for maintaining cultural and ethical identity of India. Therefore, there is a need to acquaint our teachers and students with the life and work of such epoch-making thinkers. Not much of work has been done relating to Late Babu Jagajivanram, who was instrumental in several social reforms and movements in India. For pursuing the studies and promoting knowledge relating to the Principles and Philosophy of this great nationalist, a separate Chair is being established at the University of Mysore.

The Government of Karnataka Vide its Order No.ED/UMV/99 Dated 5-10-1999 has already released Rs.10/- lakhs for establishment of a Chair in the name of late Babu Jagajivanram. Keeping this fund as corpus amount the University proposes to institute a Chair and organize research, publication and extension activities to realise the ideas and ideas of Late Babu Jagajivanram. The University also plans to mobilise additional grant from different means so as to increase the corpus fund and conduct more and more programmes to accomplish the set objective of the Chair.

It is under the above background, statutes relating to the establishment of Babu Jagajivanram Chair in the University of Mysore have been framed under Section 23 (2) (h) read with Section 35 (n) of Karnataka State Universities Act 1976

**I. Title and Commencement:**

1. These Statutes shall be called as "Statutes relating to the Establishment of Babu Jagajivanram Chair in the University of Mysore, 2000".
2. These Statutes shall come into effect from the date of assent of the Chancellor.

## II. Location:

Sri Babu Jagajivanram Chair shall be located in the Department of Studies in Political Science, Manasagangotri, Mysore. The Chairperson, DOS in Political Science shall be the Co-ordinator of the Chair and he/she in consultation with the members of the Department Council, carryout all the tasks related to this Chair and maintain the book of accounts, proceedings of meeting and records of research scholars and other staff member working under this chair.

## III. Objectives:

The specific objectives of the Chair are:

- a) To promote the ideals of Sri Babu Jagajivanram among the faculty members and students and public of the University jurisdiction by delivering Special lectures on some identified topics and by carrying on extension activities on development of dalits.
- b) To Conduct and supervise research studies on the Social reformation brought forward by Sri Babu Jagajivanram; and
- c) To Conduct field visits and collection of further literature on the social thinker and to publicise the Concepts through publications and television episodes through AVRC, Dooradarshan programmes.

## IV Staff:

1. There shall be a Visiting Professor who shall be appointed on invitation by the Syndicate for a period of not less than 3 months and not exceeding 6 months during the academic year.
2. The Visiting Professor shall be selected from amongst eminent Scholars in the field of Political Science, Philosophy, Sociology and History.
3. The Visiting Professor shall be eligible for an honorarium of Rs.8,000-00 per month and he / she shall be Provided with free accommodation in the University Guest House.
4. Admissible TA and DA shall be provided to the Visiting Professor at the time of joining and leaving the position, by the University.
5. The Visiting Professor shall plan, organise and guide the co-ordinator and research fellows to carry on the activities of the Chair to accomplish and adjectives. He / she shall also give series of Lectures conduct extension programmes and publish literatim on and about Babu Jagajivanram in co-operation with co-ordinator and research fellows.

6. The Visiting Professor at the end of his term shall submit a brief report of the activities carried on and progress made under the chair during his / her tenure.

#### V Research Fellows:

1. In order to maintain the uninterrupted continuity of the activities and the continuity of the Chair, There shall be 2 Research Fellows appointed for the Chair at any given time.
2. They shall be paid monthly fellowship on par with the University Research Fellows and conditions of their appointment shall also be in accordance with the University Research Fellow. However, their Tenure of appointment shall be initially for two years which can be extended by 1 or 2 year(s). They shall be selected by a committee consisting 4 members nominated by the Vice-Chancellor. The Vice-Chancellor shall be the Chairperson of the committee.
3. The Research Fellows shall be appointed from candidates possessing Post-Graduation in the subjects Stipulated under section IV (2) of these Statutes.
4. Their duties and responsibilities are to collect data required, conduct research in the concerned field and help the Visiting Professor / Co-ordinator in their functions that are assigned to by these Statutes, so as to achieve the objectives covered in these Statutes.
5. The Chairman, DOS in Political Science who acts as Co-ordinator of the Chair shall maintain the Research and administrative records of the research fellows and others during the absence of the Professor of the Chair.

#### VI MONITORING AND REVIEW:


1. There shall be an Advisory Committee constituted by the University Syndicate consisting of atleast 5 Members including the Visiting Professor, Chairperson of the DOS in Political Science as Co-ordinator for the purpose of monitoring the progress made in the activities of the Chair.
2. The Chairperson, DOS in Political Science in consultation with the Visiting Professor shall propose the composition of members for the approval of the Vice-Chancellor.
3. The committee shall meet once in six months and review the progress of the activities under the Chair.
4. The Visiting Professor and the Research fellows shall present the details of the work done by them During the previous six months. In the absence of the Visiting Professor, the Chairperson of the Department shall present the summary.
5. The Proceedings of the committee shall be sent to the University within one month from the date of the meeting & the same shall be placed before the Syndicate for information and consideration.

1. The University has received from the Government of Karnataka a sum of Rs. 10,00,000/- (Rupees Ten Lakhs only) as an endowment of the Chair. This amount of Rs. 10,00,000/- shall form a corpus of the Chair.
2. The University shall open a separate account in a scheduled bank and deposit the endowment amount, alongwith the already accumulated interest, if any.
3. During each financial year, the interest accrued on the endowment shall be made use on various items of expenditure such as honorarium of Visiting Professor, fellowship to the Research Fellows, travelling expenses, publication of lectures delivered during the term as Visiting Professor in the University, conducting Seminars / Study Circles, Stationery and local transportation etc.
4. Any unspent balance during a particular financial year shall be added to the corpus.
5. The University shall mobilise for additional resource from different agencies, philanthropist's etc. and add to corpus so that more amount will be available in future for activities to accomplish the objectives.
6. Detailed account of receipt and expenditure be maintained by the Co-ordinator and be got audited by the Government Auditor annually and such an audited statement of account be presented before the Advisory Committee and the Syndicate.

#### VIII. MISCELLANEOUS:

The Syndicate shall take necessary decision on any other issue that is considered essential for accomplishing / furthering the objectives of the chair without any Financial Commitment either on the part of the Government or from the University. It shall also have the power to review the activities of the Chair from time to time and appoint an expert committee if necessary to study and suggest various means for improving the activities of the Chair.

Statutes Relating To "Babu Jagjivan Ram Studies, Research And Extension Centre" Framed Under Section 29[2][1][], 34[6][7] [8] And 33[1][2] Of The Karnataka State Universities Act-2000

1. Preamble:

India is a unique country with unity in diversity. Over the years many eminent personalities in different spheres have contributed to shape the destiny of this great nation. Babu Jagjivan Ram is one among them. Born in a poorest of the poor family in Bihar- the most backward region- Jagjivan Ram rose to the status of Deputy Prime Minister of this world's biggest democratic country. Known for his courage, dynamism, intelligence and oratory skills even during childhood days, Ram was attracted by great leader like Madan mohan Malvia, Mahatma Gandhi, Rajendra Prasad, Sardar Patel, Pandit Jawaharlal Nehru and many others. Worked hand in hand with these leaders in freedom movement, he naturally occupied key positions in Central Ministry nearly four decades. Having held important portfolios like Defence, Agriculture, Railways, Labour, Babu Jagjivan Ram made his name felt at every place. It is Jagjivan Ram who called for Green Revolution and thereby made the country and its millions of people free from the problem of food and starvation and achieve self-sufficiency in food production. His initiatives for enactment of labour laws and reformation in Indian Railways made industries and railways to flourish. As a Defence Minister, Ram exhibited highest order of discipline and civility and kindled the minds of youth to gain self-confidence and thereby raised the flag of India's Defence Force on the International map. His contribution towards the post emergency crystallization of democratic norms was considerable. As a people's representative with commitment, leader with dynamism, reformer with concern, Champion of Social Justice and advocate of democracy, Ram left unforgettable stamp in the Parliament.

Babu Jagjivan Ram was thus, one among rare gems of mother India. His thinking and ideals for social reformation and nation building have reflected in his speeches in the parliament and outside. These have more relevance in today's global society. With a view to carry out in-depth study of the contribution of Babu Jagjivan Ram and to disseminate the basic tenets and values propounded by him, it is proposed to establish "*Babu Jagjivan Ram Studies, Research and Extension Centre*" in the University of Mysore as it is not only one of the oldest University in the country but has always initiated new experiments and programs in higher education and set its leadership edge in reaching the fruits of higher education to



Recognizing the contribution of this rare gem, the Government of Karnataka on the request of the University sanctioned Rs. 10.00lakhs vide Order No ED 60 UMV 1999, Bangalore dated 5.10.1999 to establish a Chair in the name of late Sri Babu Jagjivan Ram. Accordingly, Statutes for establishing Babu Jagjivan Ram Chair were framed and got approval of the University Syndicate and Senate and the Government. The Chair was formally inaugurated on 18<sup>th</sup> August 2003 in the University of Mysore. Further, keeping in view the Birth Centenary Year [2007] of late Sri Babu Jagjivan Ram, the University Grant Commission, New Delhi has extended financial assistance and four posts of teaching and research under special Grant vide order No.F.6-4/2003[SU-I] dated 5<sup>th</sup> December 2006. As per existing Statues the Chair is attached to the Department of Political Science. It is proposed to bring this Chair and also the special grant provided by the UGC within the ambit of the proposed Centre. Hence the following Statutes have been framed.

## 2. Short Title:

These Statutes shall be called "*Babu Jagjivan Ram Studies, Research and Extension Centre Statutes-2008*" framed under section 29 [2][1], 34[6],[7][8] and 33[1] [2] of the Karnataka State Universities Act-2000

## 3. Commencement:

These Statutes shall come into force from the date they are assented to by His Excellency the Chancellor.

## 4. Brief Description:

The Babu Jagjivan Ram Studies, Research & Extension Centre shall be one of the teaching and research department of the University of Mysore and shall offer Courses reflecting Babu Jagjivan Ram's thoughts on different areas. The Centre shall conduct teaching and research programmes leading to Certificate, Diploma, Graduate, Post-Graduate, M Phil and Ph D degrees and organize extension programmes on various social issues relating to agricultural economics, food production, Defence management, labour welfare, secularism, social harmony and social reforms including empowering weaker sections and women and thoughts and ideals of Babu Jagjivan Ram.

5. Objectives:

- a. To study Babu Jagjivan Ram's thoughts and ideals and their relevance to the contemporary society;
- b. To study the impact of socio-political and economic factors on Jagjivan Ram's thinking and practicing;
- c. To compare and contrast Jagjivan Ram's thoughts and ideologies with other socio-political thinker in the context of reconstruction of Indian society;
- d. To offer courses at different levels on the following areas and the ideals of Babu Jagjivan Ram.
  - I. Agricultural productivity and food markets;
  - II. Social problems, social reforms, poverty alleviation and welfare economics;
  - III. Defence management;
  - IV. Secularism, social harmony and economic development;
  - V. Dalit literature and advocacy of human rights and democracy;
  - VI. Communication media and transport economics;
  - VII. Any other area of current interest that has relevance to Babu Jagjivan Ram's thoughts; and
- e. To undertake research, publishing, training and extension activities on and about Babu Jagjivan Ram and his thinking and related areas.

6. Departmental Council:

As provided under section 34 [6] of Karnataka State Universities Act 2000, the Centre shall have the Departmental Council consisting of the members as prescribed there in.

7. Board of Studies:

As prescribed in Section 33[1] & [2] of the KSU Act -2000, there shall be a Board of Studies in Babu Jagjivan Ram's Thought and Allied Studies and shall carry on its functions as per the provisions of the Statues of the University in this regard.

The Centre shall have the following staff:

Note: 1. The syndicate shall identify one vacant post of Professor in the University and designate this position as Professor -cum-Director. The University Syndicate also shall identify suitable vacant posts in different departments in the University of Mysore for other positions and redeploy them to the Centre.

#### 9. Babu Jagjivan Ram Chair:

I. The Government of Karnataka on the request of the University sanctioned Rs.10.00 lakhs vide Order No.ED 60 UMV 1999, Bangalore dated 5-10-1999 to establish a Chair in the name of late Shri Babu Jagjivan Ram. Accordingly, statutes for establishing Babu Jagjivan Ram Chair were framed and got approval of the University Syndicate and Senate on 23-09-2000 and 30-09-2000 respectively and these Statues received assent of His Excellency the Chancellor on 23-6-2001. The Chair has been established in the year 2001 vide University notification No.DV.7/Misc/97-98 dated 29-8-2001 and was formally inaugurated on 18<sup>th</sup> August 2003. as per the existing Statue Sri Babu Jagjivan Ram Chair is attached to the Department of Studies in Political Science. Since an independent Center i.e., Jagjivan Ram Studies, Research & Extension Centre is proposed to be established under the present statutes, this Chair hereafter shall be attached to this Babu Jagjivan Ram Studies Research and Extension Centre. However, the chair will continue it's functioning as per the provisions of the existing statutes framed for this purpose.

#### II. Location of the Chair:

"Babu Jagjivan Ram Chair" shall be located in the "Babu Jagjivan Ram Studies, Research & Extension Centre" and here after shall form part of the said Centre.

#### 10. UGC Assistance:

[a] The UGC vide Order No. F.6-4/2003[SU-I] dated 5<sup>th</sup> December 2006 has sanctioned following teaching and Research positions and has extended financial assistance for a period of five years.

[d] The above positions be filled on contract / deputation basis observing the qualifications requirements provided in this Statute for the period the UGC extends financial assistance and they stand abolished when the UGC ceases its assistance.

[e] Any asset created out of the assistance of the UGC or any other agency will form part of the Babu Jagjivan Ram Studies, Research & Extension Centre.

#### 11. Educational Qualification Requirements for Teaching and Research Positions:

[a] Professor/ Professor-cum-Director: [Rs.16400-450-20900-500-22400]

The incumbent shall be an eminent scholar with published work of high quality and shall be actively engaged in research with a minimum of TEN years experience in Post-Graduate Teaching and / or Research in Social Sciences/ Humanities / Education/ Law at the University / National Level Institutions.

Experience in i) Guiding Research at Doctoral level; and ii) Research and Publication activities on and about Babu Jagjivan Ram are desirable.

OR

An outstanding Scholar with established reputation who has made significant

**[b] Reader: [Rs.12000-420-18300]**

i] Prospective candidates shall have consistently good academic record with a Doctorate Degree in Social Sciences/ Humanities / Education/ Law from Indian University or from Foreign University or equivalent published work. Candidates from outside the University system, in addition shall also possess at least 55% marks or an equivalent grade of 'B' in the 7 point scale with letter grades. O,A,B,C,D,E, & F at the Master's degree level in either of the discipline mentioned above.

ii] Applicants shall possess Five years experience of teaching and / or research excluding the period spent for obtaining Ph.D. degree, and shall have made some mark in the areas of scholarship as evidenced by quality of publications, contribution to educational innovation, design of new courses, curricula, etc.

iii] Research and Publication activities on and about Babu Jagjivan Ram are desirable.

**[c] Lecturer: [Rs.8000-275-13500]**

- I. Prospective candidates shall have consistently good academic record with at least 55% marks or an equivalent grade of 'B' in the 7 point scale with letter grades. O,A,B,C,D,E, & F at the Master's degree level in Social Sciences/ Humanities / Education/ Law from an Indian University or an equivalent degree from a Foreign University.
- II. Candidates, besides fulfilling the above prescribed qualifications, should have cleared the National Eligibility Test [NET] for lecturers conducted by the University Grants Commission/CSIR or a similar test accredited by the University Grants Commission.

Candidates besides fulfilling the above prescribed qualifications, should have cleared the JRF / National Eligibility Test [NET] for lecturers conducted by University Grants Commission/CSIR or similar test accredited by the University Grants Commission; and
- II. Knowledge of data collection through field study / Literature survey and data analysis using different software, like SPSS.

**Desirable:**

- I. Research experience leading to Ph.D or M.Phil in the above areas.

Candidates besides fulfilling the above prescribed qualifications, should have cleared the JRF / National Eligibility Test [NET] for lecturers conducted by University Grants Commission/CSIR or a similar test accredited by the University Grants Commission; and

**Desirable:**

- I. Knowledge of data collection through field study / Literature survey and data analysis using different software, like SPSS.
- II. Knowledge of translation from Hindi / English to Kannada and Vice - Versa.

**(f) Post- Doctoral Fellow:**

Prospective candidates shall have consistently good academic record with a Doctoral degree in Arts / Humanities / Social Sciences/ Education/ Law and shall be actively engaged in Research with a minimum of five years experience in Post-Graduate Teaching and / or Research at the University / National Institution.

**(g) Visiting Fellowship:**

An outstanding Scholar with established reputation who has made significant contribution to knowledge in general and Welfare Economics, Social Reforms/ Agricultural Economics / Law and Legislation / Dalit Literature / Defence Management in particular.
