STATUTE RELATING TO THE ESTABLISHMENT OF PLATINUM JUBILEE CHAIR  
FOR SWAMI VIVEKANANDA STUDIES IN THIS UNIVERSITY, FRAMED UNDER  
SECTION 35(n) OF THE KARNATAKA STATE UNIVERSITIES ACT, 1976.

**I TITLE AND COMMENCEMENT.**

- 1) The Statute shall be called " Statute relating to the establishment of Platinum Jubilee Chair for Swami Vivekananda Studies ".
- 2) The Statute shall come into effect from the date of appointment of the Chancellor.

**II LOCATION.**

The Chair shall be located in the Department of Studies in Philosophy, Manasagangotri, Mysore.

**III OBJECTS.**

- 1) The object of the Chair is to have an indepth study of literature of Swami Vivekananda.
- 2) The impact of the literature of Swami Vivekananda on the different religions.
- 3) Co-ordination of different religion on the basis of the literature of Swami Vivekananda.
- 4) Comparative study of Swami Vivekananda thoughts, lectures in India and abroad, with the present social order of the Society.
- 5) Publication of Swami Vivekananda literature, thoughts and lectures etc.,

**IV (A) Visiting Professors:**

- 1) There shall be a Visiting Professor/Scholar who shall be appointed on invitation by the Syndicate for a period not less than 6 months and not exceeding one academic year.
- 2) Visiting Professor shall be selected from amongst eminent Scholars in the Field of Philosophy and Scholars from Ramakrishna Missions in India and abroad.
- 3) The eminent personalities who may be able to deliver lectures on different religions.
- 4) Noted Saints, Spirituals who have done Considerable works in that field may be considered as Visiting Professor to this Chair.
- 5) Visiting Professor/Scholar shall be eligible for an honorarium of Rs.8,000/- per month and free accommodation in the University Guest House, Manasagangotri, Mysore. In case of In-service Professors/Scholars his/her total emoluments will be protected.
- 6) A Contingency Grant of Rs.15,000/- will be provided for the Visiting Professor/Scholar.

Amendments to the Statutes relating to the Tenure of appointment i.e., IV (A) Visiting Professor for Swami Vivekananda Chair.

TITLE AND CONNENCEMENT

1. These Statutes shall be called as Amendments to the Statutes relating to Tenure of appointment of Visiting Professor under Swami Vivekananda Chair.
2. These Statutes shall come into effect from the date of assent of the Chancellor.

IV(A) VISITING PROFESSOR

1. There shall be a visiting professor/ Scholar who shall be appointed on invitation by the Syndicate for a period of not less than 6 months and not exceeding one academic year.
