

The Award will consist of Rs. 21,000.00 (Rupees Twenty One Thousand Only), a certificate, a citation and a memento. Selected candidate along with his/her escort shall be provided to and fro AC 2 tier railway fare on concessional rates and hotel accommodation at the time of Award ceremony on 4th January, 2022.
