# About the Conference

Recognising the role academic institutions play as knowledge hubs that enable individuals to develop the skills to achieve SDGs, the Knowledge Partnership explored existing formats for collaboration between universities to revise and harmonise their curriculum related to sustainability. Business schools in particular play an important role in the development of leaders who are socially responsible, regionally conscious and who prioritise sustainability. As an Interdisciplinary Conference open to participants from Engineering, Management, Social Science and Natural Science Disciplines, discussions and outcomes at the Conference will be focussed on ways and means to advance the SDGs through Knowledge Partnerships.

The First Conference held in 2017, was on the theme of "Sustainable Consumption and Lifestyles' and covered in 9 parallel workshops, the following SDGSs 3, 6, 7, 8, 11, 13 and 17. The Second Conference held on 2019 on the theme of 'Towards Sustainable Lifestyles and Inclusive Societies Building Competencies, Skills, Knowledge and Attitudes for Sustainable Futures' Keeping with the theme of the Conference 9 Master Classes were held with experts from different domains.

The Third UN SDGs Conference builds on these two conferences. As a prelude to the Conference, TSP Asia and other collaborating organizations are also organizing a workshop on, 'Supply Chains: Addressing Equity, Sustainability and Resilience Challenges' all of which are major concerns in a globalised world but more so after the pandemic put brakes on 'economic growth only' paradigms. This workshop will be followed by the main UNSDGs Conference with expert plenary sessions, parallel paper presentation and domain specialist interventions. A parallel Conference for youth and students will also take place on the theme of, 'Youth for Climate Action'.

### Background:

At the United Nations-ESCAP's Asia Pacific Forum on Sustainable Development (APfSD) held in April 2016, a special event 'Building Knowledge Partnerships: Academia and UN System Knowledge Platforms for Advancing the SDGs' was jointly organised by UNESCO, Chulalongkorn University Global Network (CGN) and The Sustainability Platform (TSP). Participants included Institute for Global Environmental Strategies (IGES), Japan and Asia Centre of the Copenhagen Business School, Denmark, Siam University and chair of the Asia Cooperative Dialogue – University Network. The 2016 APfSD saw further work on Knowledge Partnerships and this Conference builds on the work and seeks to strengthen and promote Knowledge Partnerships with practical outcomes in the Region.

Mysore is uniquely placed to host such a conversation: India's cleanest city and an emerging 'wellness city' is also where an expanding urban environment rubs up against the unique problems of its rural hinterland. The Conference will examine international perspectives on the UN SDGs as well as issues that confront a fast-changing rural India, with special reference to challenges in the areas of Climate Action, Equity and Sustainability in Supply Chains and Public Policy Challenges and in synergising partnerships between Knowledge Institutions, business and civil society groups can make.

# The Sustainability Platform (TSP) Asia:

# University of Mysore (UoM):



UoM was established on July 27, 1916. It is the sixth oldest University in the country and the first in the state of Karnataka. The university was founded by His Highness Shri Nalvadi Krishnaraja Wadiyar – IV (1884-1940), erstwhile Maharaja of Mysore and Diwan Sir M. Visvesvaraya (1860-1962). It was the first University to be accredited by NAAC in 2000 with Five Star Status. The university is now ranked 33rd in the India Rankings 2022, NIRF-MHRD, Government of India. The UoM offers

academic Programmes in Arts, Science, Commerce and Management, Law, Education, Engineering and Architecture.

B.N. Bahadur Institute of Management Sciences (BIMS): University of Mysore set up the Department of studies in Business Administration (DOSBA) in 1974. The great leap forward came in 2002 when Dr. B.N. Bahadur an alumnus of the University and President of the B.N.Bahadur family foundation of Michigan, U.S.A made handsome donation, which together with contribution from the University built "B.N.Bahadur Institute of Management Sciences", (BIMS) situated at the northern edge of 'Manasagangotri' campus. BIMS, set in a sylvan expanse, is a unique piece of architecture that accommodates around 450 students including international students from across 25 countries each year.

All submissions must be written in English language and must be made in Microsoft Word format (.doc/docx) only. Authors are invited to submit manuscripts for review covering - Conceptual analyses and theoretical presentations related to the 10 SDGs of the Conference. Integrative literature reviews and meta-analyses that produce important new insights and research questions. Manuscripts will be initially screened by the Technical Committee for adherence to these guidelines, in particular for originality, readability, and potential contribution to the literature. Please Note papers submitted must be in relation to the UNSDGs Conference and the sub-themes only. Those passing this screening will then be subject to a double blind peer review process. Please follow strictly the following general quidelines:

- → Paper size: Standard A4
- → Font and size: Times New Roman 12 pt, line space double.
- → Margins: 1" on all sides
- → Justified text
- → Do not include page headers and footers.
- → All figures/tables should be integrated in the text. The figure caption style should have the same font and size as the main text.
- → Word count: Max. 3,000 words including the abstract.

# **Publication**

Accepted full papers meeting publication requirements will be published in Peer Reviewed / Refereed Journal. Please ensure that the manuscript has been "spell-checked" and "grammar-checked".

All papers should be based on original work. Plagiarism constitutes grounds for disqualification. The entire manuscript (including cover page, abstract, main text, exhibits, appendices, and references) should be included in one document. All author related information name, affiliation, and contact details should be mentioned only in the cover page. Any information conveying identification of the author(s) (including name, affiliation, and acknowledgments) must be removed from the manuscript for peer review purposes.

The authors need to send along with the paper the certificate of originality-cum-consent for publication in proceedings without which it will not be accepted. All the papers will be blind reviewed by an expert committee with respect to their quality, originality, and relevance. Articles will be subject to plagiarism check before being sent for review process.
