

**STATUTES relating to Recognition of Institutions as Research Centres framed
under Section 54 read with Section 36 of the Karnataka State Universities' Act,
1976.**

1. On receipt of a request or a proposal from the Head of an Institution, Research Centre, Research Laboratory other than a College located within or outside the Karnataka State or from a member of staff of the Institution concerned or the Head of the Department of the University in the subject for recognizing an Institution / Laboratory, the Syndicate may accord Recognition to the following Institutions as centers for purposes of carrying on research by candidates registering for Ph.D. Degree in the Mysore University.

- i) Laboratories of an All India nature or other Institutions maintained by the Government of India where research work is going on:
- ii) Research Institutions maintained by a State Government or a quasi Government / autonomous Institution recognized by the Central or State Government and where necessary facilities for research and qualified staff are available to guide research students.

2. The Syndicate shall consult the Board of Studies in the respective subjects and / or appoint a Commission to inspect the Institution and submit a report before arriving at a decision in the matter of recognition of an Institution.

3. The Syndicate, while recognizing an Institution, may specify the subject or areas for which the Institution is recognized.

4. Where the University taken up the question of recognition of an Institution on its own, the payment of recognition / commission fee of Rs.200/- (Rupees two hundred only) by the Institution concerned may be waived by the University Syndicate at its discretion.

5. When an Institution is recognized in the above manner, a candidate intending to carry on research in such an Institution shall ordinarily work under the guidance of a member of staff of that Institution approved by the Univ.

6. Recognition accorded to an Institution may be subsequently withdrawn by the Syndicate in full or in part or modified on the recommendation of the Board of Studies in the respective subject/s.

CONDITIONS (FOR RECOGNITION)

1. The scholars and experts of the said institute should come and deliver lectures to the students of University of Mysore on request by the concerned departments without TA/DA. However, such experts will be paid prescribed honorarium for the lecture they deliver.
2. They should extend academic interaction and co-operation with the faculty and scholars in the University of Mysore.
3. In the event of award of Scholarship / Research Fellowship by the said institute, the eligible post graduate students of our University shall be given preference over others.
4. Recognition is accorded on annual basis and would be subject to renewal on the basis of requisition of the institute by paying the prescribed renewal fee.
5. Annual Report about the progress of research work of the Institute should be submitted every year to the University.
6. The Doctoral Committee for Ph.D students of Institute/College/Trust should have at least one representative from the respective department of the University of Mysore, Mysuru.
