Further, the following terms and conditions have been imposed to the CAS promotions given to the teachers mentioned in the SLNo 02, 03, 04, 05 who were appointed during the 2007.

1. This promotion is subject to the decision of the Government of Karnataka regarding their appointment in the University of Mysore.
2. This promotion is subject to the result of the Writ Petition No. 9584/2007, which is pending before the High court of Karnataka.
3. In case the result of the writ petition goes against the teachers, the amount paid is liable to be recovered.
