*STATUTES RELATING TO RULES OF RECRUITMENT OF
DEPUTY REGISTRARS / DEPUTY REGISTRARS (EVALUATION) AND
ASSISTANT REGISTRARS / ASSISTANT REGISTRARS (EVALUATION)*

(framed Under Section 29(2)(1) and 41(1)(2) of KSU Act 2000)

Preamble:

In the University of Mysore the number of Second Division Clerks and First Division Clerks at the base level is more and there are only 08 posts of Deputy Registrars and 10 posts of Assistant Registrars. Out of these 08 posts of Deputy Registrars 50% are filled up by teachers working in the University on deputation basis and the remaining 50% are filled from among Assistant Registrars on the basis of selection as per the existing statutes of the University of Mysore. Among 10 posts of Assistant Registrars 25% are filled by teachers working in University on deputation basis and 75% are filled up by promotion of Superintendent on seniority cum reservation basis.

Since the posts at higher cadre are very few, the opportunities for promotion to non-teaching staff from lower level to the higher cadre are very remote. On the contrary, it is learnt that the post of Deputy Registrars and Assistant Registrars in other Universities are filled by promotion from among non-teaching staff of respective lower cadres.

Therefore the Non-Teaching Staff Association of our University has urged to consider only Non-Teaching Staff for promotion to the Cadre of Deputy Registrars / Deputy Registrars (Evaluation) and Assistant Registrars / Assistant Registrars (Evaluation), as existing in other Universities in the State.

After discussing with the Non-Teaching Association Office bearers, the University has proposed to reduce the ratio of deputation of teachers for the Posts Deputy Registrars from 50 to 25% and also to fill up all the posts of Assistant Registrars / Assistant Registrars (Evaluation) by promoting the Superintendents on the basis of seniority.

Further, it is learnt that Karnataka Government Secretariat Service (Recruitment Rules) 1992 does not insist upon higher academic qualification for the promotion of Under Secretaries to the Cadre of Deputy Secretaries.

Hence, it is proposed to bring the following amendments to the existing Statutes relating to Rules of Recruitment to the posts of Deputy Registrar / Deputy Registrar (Evaluation) and Assistant Registrar / Asst. Registrar (Evaluation).

IV. Lecturer (Core Faculty)

Essential: (a) Master's Degree in Urban and Regional Planning or its equivalent
(b) Two years of Post-Graduate Teaching or Professional experience in Urban and Regional Planning.

V. Lecturer (Supporting Faculty)

Essential: (a) Master's Degree in Geography or Economics or Sociology.

- (b) Doctoral Degree in relevant subject as in (a) or publications in Urban and Regional Planning.
(c) Two years of Post-graduate or Under-graduate teaching experience.

12.5 *Rules of Recruitment of Deputy Registrar/Deputy Registrar (Evaluation) & Assistant Registrar/Assistant Registrar (Evaluation)

1. *Definition:* These Statutes shall be called as the Statutes relating to prescription of uniform rules of recruitment to the Administrative posts in the University of Mysore Statutes 1980.

2. *Scope:* (i) 50% of the posts of Deputy Registrars/Deputy Registrars (Evaluation) shall be filled by deputation from among the University teachers and 50% of the posts shall be filled by promotion by selection from among the Assistant Registrars/Assistant Registrars (Evaluation), working in the University of Mysore, as indicated in the method of recruitment.
(ii) 75% of the posts of Assistant Registrars/Assistant Registrars (Evaluation) shall be filled by promotion from among the Superintendents working in the University of Mysore who have served for at least two years as Superintendents on the basis of seniority-cum-merit and 25% of the posts shall be open to the teaching staff of the University of Mysore (University and Affiliated Colleges are included for this purpose) who have put in not less than 5 years of service as teachers in the University of Mysore.
(iii) Persons coming from the teaching cadre against the posts of Deputy Registrars, Deputy Registrars (Evaluation) Assistant Registrar, and Assistant Registrars (Evaluation) shall be appointed on tenure basis for a period of not exceeding three years.
(iv) Following shall be the Rules of Recruitment governing the appointments to the posts of Deputy Registrars/Deputy Registrars (Evaluation) and Assistant Registrars/Assistant Registrars (Evaluation), University of Mysore, Mysore.

1. Deputy Registrar/Deputy Registrar (Evaluation)

Grade: Rs. 1,725-75-2,250-100-2,350.

Qualification

- (i) Master's Degree relaxable to Bachelor's Degree in case of In-service persons coming from ministerial cadre.
(ii) Candidates coming from the category of teachers should possess at least 10 years of teaching experience in the University of Mysore (University and affiliated colleges are included for this purpose).
(iii) Candidates coming from non-teaching cadre should possess total administrative experience of at least 5 years in the University of Mysore, out of which they shall possess at least 2 years of experience as Assistant Registrars/Assistant Registrars (Evaluation).

Period of Probation: Nil

Method of Recruitment

- (i) 50% of the posts shall be filled by deputation from among University teachers of the cadre of Readers and those Lecturers drawing the pay more than the Minimum of the Scale of the post and
(ii) 50% of the posts shall be filled up by promotion by selection from among the Assistant Registrars/Assistant Registrars (Evaluation) through Board of Appointments under Sec. 50 of KSU Act, 1976 without reference to their seniority.

(ii) 25% of the posts by selection from among the teaching staff of the University of Mysore (Affiliated Colleges are included for this purpose) who have not less than 5 years of teaching experience in the University.
