**STATUTES GOVERNING ESTABLISHMENT OF STATISTICAL CELL OF
THE UNIVERSITY OF MYSORE 2015**

Preamble:


It has been felt expedient that a permanent Cell for collecting, compiling, storing and communicating statistical information relating to students, staff, administration, examination, finance and about assistances given to SC/ST/OBC within the University shall be established as a well coordinated body.


The UGC in its letter dated 18th August 2009 has intimated to the University as under. On the basis of recommendations of National Statistical Commission of Government of India that Universities shall collect and compile data from the affiliated colleges; that the consolidated data on student enrolment and teaching staff pertaining to the University shall be available; and that for these purposes a Statistical Cell with qualified Nodal Officer with adequate facilities of computers, Internet etc., shall be established in the University.

The Principal Secretary to Government of Karnataka, Planning, Programme Monitoring has emphasized the crucial role of sound statistical administration, enhancement of the reliability of statistics and improvement of data collection method and resources. The Principal Secretary to Education Department (Higher Education), Government of Karnataka by his letters dated 15.7.2008, 28-1-2009 and 24-3-2009 has directed to take appropriate action to strengthen the statistical system at the University level in the light of Statistical Department's letter dated: 02-01-2008.

In the aftermath of Right to Information Act 2005, the need to access and transmit appropriate statistical information in a time bound manner has been realized by the University Administration.

Hence these Statues are framed:

1. Title and Commencement:

- (i) These Statutes shall be called " The University of Mysore **(ESTABLISHMENT OF STATISTICAL CELL** Statues, 2015)"
- (ii) These Statutes shall come in to effect from the date of assent of the Chancellor.

2. Establishment of an Statistical Cell:


There shall be established in the University, a statistical Cell as a separate and full fledged unit with a Nodal Officer as its head, working under the supervision of the Registrar. The Cell shall be well equipped with necessary computers and other infrastructural facilities.


3. Functions of Statistical Cell:

The functions of Statistical Cell shall include

(i) Collection and compilation of data about:

- a. Academic and developmental activities of the University, funds received from various agencies and purposes for which they were spent.
- b. Profile of the departments and constituent colleges with details about teaching and non-teaching staff;
- c. Course-wise admission of students, their sex ratio and the number of students availing reservation benefit in various categories:
- d. Examinations-students appearing for different examinations, percentage of pass and other details about results.
- e. Statutes, Regulations and Ordinances of the University relating to various issues:
- f. Financial assistance given to SC/ST, OBC, minorities from various Government Departments in any year:
- g. Funds received by the Finance Section under various heads and spent for various purposes

- (ii) Transmission of data to University Grants Commission (UGC), Ministry of Human Resource Development (MHRD) and other Governmental Departments at the Centre and State whenever called for.
- (iii) Furnishing relevant statistical information to the Parliament and State Legislative, Secretariat in the context of questions and queries as and when enquired.
- iv) Generating strong data base of the University and updating it from time to time.


4. Nodal Officer and Other Staff:


- i) There shall be a full time Nodal Officer having educational qualifications of M.Sc (Statistics)/M.Sc Computer Science with knowledge of data base management and Ph.D degree in the relevant subject to supervise performance of the functions of Statistical Cell as its head.
- ii) The Post Nodal officer shall be filled up by deputation from among persons working in the of Department of Studies in Statistics or Computer Science or from other officers of the University.

The post of Nodal Officer may be filled on deputation from among the Readers or Lecturers of the University/Constituent Colleges.

The Services of the following posts which are necessary shall be availed from the existing staff of the University who are suitable for these Posts:

5. Functions of Nodal Officer:


1. Nodal Officer shall direct and oversee proper functioning of STATISTICAL CELL.
2. He shall help the Registrar in procuring and supplying relevant information/Data required by University/Government/UGC and other Government agencies.

6. Power of Nodal Officer and Statistical Cell



He shall have powers to procure and supply information/Data from Post-Graduate Departments/Constituent Colleges/affiliated colleges/Vice-chancellor's Secretariat and various sections of Registrar, Registrar (Evaluation), Finance Officer and other Statutory and Non-Statutory Officers of the University of Mysore.

7. Finance

Non-recurring grants to establish the cell shall be Rs.10,00,000/- (Ten Lakhs Rupees) payable by the State Government.
