The Board of Studies in English (PG) which met on 05<sup>th</sup> November 2015 has resolved and recommended the changes in the existing Eligibility Criteria for M.A. English admissions as follows from the academic year 2016-17.

Existing	Revised
B.A. with English as a major or optional subject or B.A.Ed. (Regional Institute of Education) or Degree with Postgraduate Diploma in English of the University of Mysore or B.A./B.Sc., B.A. Performing Arts with not less than 50% marks in English Language or English Minor.	Students having Optional English in BA/B.Sc., BA Performing Arts/B.A.Ed (RIE) Degree of PG Diploma in English of the University with 50% marks for General merit candidates and 45% for SC/ST/Cat.I. Language English students are not eligible to apply for admission or to appear for Entrance Test for M.A. English.

The Faculty of Arts and the Academic Council at their Meetings held on 20<sup>th</sup> February 2016 and 29<sup>th</sup> March 2016 respectively have also approved the above said proposal and it is hereby notified.
