AFTER AMENDMENT, THE STATUTES TO ESTABLISH SCHOOL OF PLANNING AND ARCHITECTURE SHALL BE AS UNDER:

Preamble:

The Statutes relating to establish the School of Design are assented to by His Excellency the Chancellor and communicated the same by the Principal Secretary to Government, Education Department (Universities), in its letter No. ED 10 UMS 2014, dated 25.4.2015. According to the approved Statutes, the School of Design is a self-financing Institution without any financial aid from the State Government.

There exist in the University the Institute of Development Studies which has three sections viz., the Urban & Regional Planning, Agricultural Marketing Management and Development Studies. These three sections have their own sanctioned posts.

The Urban & Regional Planning and Architecture should co-exist to carry out the planning and architecture to meet the needs of citizens of the country. In almost all foreign Universities and also Indian Universities, the Planning and Architecture are treated as co-existing for the purpose of academic and research activities. Therefore, it is necessary to attach the Urban & Regional Planning section existing in the Institute of Development Studies with the School of Design to conduct the following courses and also research:

- 1) Bachelor Degree in Planning (B Plan four years course)
- 2) Bachelor Degree in Architecture (B.Arch. five years course)
- 3) M.Tech in Urban and Regional Planning (two years or four semesters)
- 4) Master of Architecture (two years or four semesters)

The committee of experts in Town Planning and Architecture constituted by the Ministry of Human Resource Development, Department of Higher Education, Government of India, have already planned to increase the intake of students in the above courses so that the qualified persons could able to meet the emerging demand of the country.

Without any additional financial commitment on the part of the State Government, it is proposed to attach the already sanctioned teaching posts in Urban and Regional Planning from the Institute of Development Studies to the School of Design and also to change the nomenclature of School of Design as School of Planning and Architecture.

Hence the following amendment Statutes.

IN EXERCISE OF POWERS CONFERRED UNDER SEC. 29(2)(t) READ WITH SEC. 31(2)(xii) AND SEC. 40(1)(f) AND ALSO SEC. 41, OF KARNATAKA STATE UNIVERSITIES ACT, 2000, THE SYNDICATE MAKES THE FOLLOWING STATUTES.

I. TITLE AND COMMENCEMENT:

- 1. These Statutes shall be called The University of Mysore (establishing the School of Planning and Architecture Amendment) Statutes, 2015.
- 2. These Statutes shall come into effect from the date they are assented to by the Chancellor.

II. DEFINITIONS:

- 1. "University" means the University of Mysore
- 2. "Act" means the Karnataka State Universities Act, 2000
- 3. "School" means the School of Planning and Architecture

- 4. "Syndicate" means Syndicate of the University of Mysore
- 5. The words which are not defined in the Statutes shall carry the same meaning as assigned to them in the Act.

III. ESTABLISHMENT OF THE SCHOOL:

There shall be the School of Planning and Architecture permanently established in the University.

IV. ATTACHING URBAN & REGIONAL PLANNING WITH THE SCHOOL OF PLANNING AND ARCHITECTURE:

The section of Urban and Regional Planning exists in the Institute of Development Studies along with the following sanctioned posts with the incumbents working against them shall now be working in the School of Planning and Architecture.

- a) Professor 2 posts
- b) Associate Professor 2 posts
- c) Assistant Professor 4 posts

V. NEW POSTS ALREADY CREATED IN THE APPROVED SCHOOL OF DESIGN STATUTES UNDER SELF-FINANCING SCHEME :

- a) Professors 2 posts
- b) Associate Professors 4 posts
- c) Assistant Professors 8 posts

One of the Professors nominated by the Vice-Chancellor shall work as Director.

VI. OBJECTS OF SCHOOL:

- (i) To support the establishment and development of School of Planning and Architecture as an Institute of excellence.
- (ii) To provide global leadership in the field of architecture, planning and allied fields.

VII. FINANCE:

For the posts shifted as shown in para IV of the above Statutes, no additional grant is required from the State Government because those posts are already included in the Block Grant.

For the new posts shown in para V of the above Statutes, they come under self-financing without any grant from the State Government.
