### TITLE AND COMMENCEMENT.

- 1) The Statute shall be called "Statute relating to the establishment of Flatinum Jubilee Chair for Swamy Vivekananda Studies".
- 2) The Statute shall come into effect from the date of append of the Chancellor.

#### II LOCATION.

The Chair shall be located in the Department of Studies in Philosophy, Manasagangothri, Mysore.

#### III OBJECTS:

- 1) The object of the Chair is to have an indepth study of of literature of Swamy Vivekananda.
- 2) The impact of the alterature of Swamy Vivekananda on the different religions.
- 3) Co-ordination of different religion on the basis of the lit rature of Swamy Vivekananda.
- 4) Comparative study of Jwamy Vivekananda thoughts, lectures in India and abroad, with the present social order of the Lociety.
- 5) Publication of Swamy Vivekananda literature, thoughts and Lectures etc.,

### IV (A) <u>Visiting Professors</u>

- 1) There shall be a Visiting refessor/Scholar who shall be appointed on invitation by the Syndicate for a period not less than 6 months and not exceeding one academic year.
- Visiting Professor shall be selected from amongst eminent Scholars in the Field of Philosophy and Scholars from Ramakrishne Missions in India and abroad.
- 3) The eminent personalities who may be able to deliver lectures on different religions.
- 4) Morad Smints, Spirituals who have done considerable works in that field may be considered as Visiting Professor to this Chair.
- 5) Visiting Professor, Coholar shall be eligible for an honorarium of M.8,000/- per month and free accommodation in the University Guest House, Manasagangothri, Mysore. In case of In-pervice Professors/Scholars his/her total emoluments will be protected.
- 6) A Continuency Crapt of 3.15,000/4 will be provided for the Visiting Professor. Scholar.

# V SCOPE.

- Holding lectures not less than 4 in a month by the Visiting Professor/Scholar on the objects stipulated in the Statute
- To give attention on the other items of the objectives during the rest of the period.
- Conducting Seminars, Workshops, Study Circles to formulate the objectives of the Statutes

# VI FINANCE:

- 1) The Expenditure may be met out from the funds collected to the Platinum Jubilee Celebrations of the University.
